

ARTICLES OF ORGANIZATION

Better Days L..L.C.

A LIMITED LIABILITY COMPANY

(Under the provisions of the Alabama
Limited Liability Company Act)

1. **Name.** The name of the limited liability company is **Better Days L..L.C.**

2. **Purpose.** The purpose of this limited liability company is to transact any or all lawful business for which Limited Liability Companies may be formed and may include the transaction of any and all lawful business for which limited liability companies may be organized in the state of Alabama.

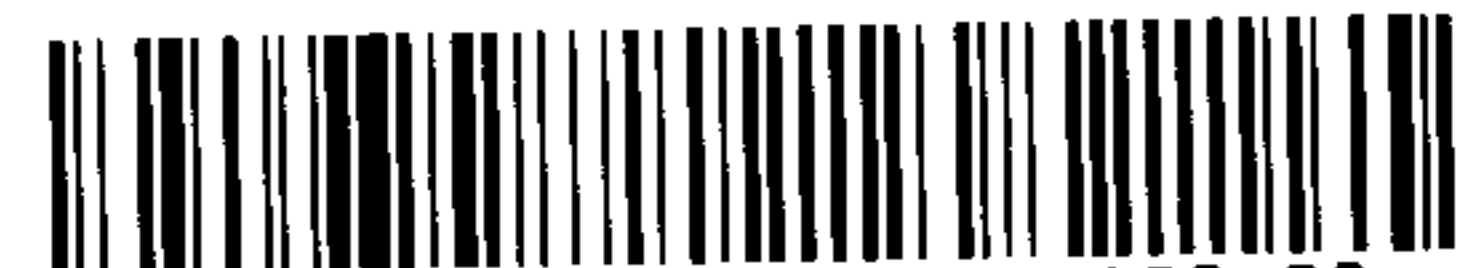
6. **Management.** The corporation will be member managed and there will be at least one member at the time the limited liability company is formed. The initial Manager shall be:

8. **Admission of New Members.** With the written unanimous consent of the members, new members may be admitted into the LLC upon the payment of such capital contribution and upon such terms as the members unanimously decide. In the event that new members are admitted into the LLC, the share of each new member in the profits and losses shall be in such proportion as may be agreed upon between all the members and the new member.

9. **Members Right to Continue Business.** The remaining members of the limited liability company shall have the right to continue business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the limited liability company as further set forth in the Operating Agreement of the limited liability company.

Any provision that is not inconsistent with the law for the regulation of the internal affairs of the Limited Liability Company is permitted to be set forth in the operating agreement of the LLC.
