**ARTICLES OF ORGANIZATION
OF
HOOVER TACTICAL FIREARMS, LLC**

The undersigned organizer, desiring to form a limited liability company pursuant to the laws of the State of Alabama, hereby certifies as follows:

1. The name of the limited liability company is Hoover Tactical Firearms, LLC.
2. The existence of the limited liability company shall commence on the date of the filing of these Articles of Organization in the Office of the Judge of Probate of Shelby County, Alabama, and its duration shall be perpetual; provided, however, that the limited liability company shall be dissolved (a) upon the written consent of all of the members; (b) as provided in the Operating Agreement; or (c) as may be required by the Alabama Limited Liability Company Act.
3. The purpose for which this limited liability company is organized is to engage in the sale of firearms and ammunition at the retail level. The limited liability company shall have the power and authority to do all things necessary or convenient to accomplish its purposes and to engage in any business permitted under the Alabama Limited Liability Company Act and the laws of any jurisdiction in which the limited liability company may do business.
4. The location and mailing address of the initial registered office shall be 427 Russet Hill Road, Hoover, AL 35244, and the name of the initial registered agent at said address shall be Peyton B. Zarzour.
5. The names and mailing addresses of the initial members of the limited liability company are as follows:

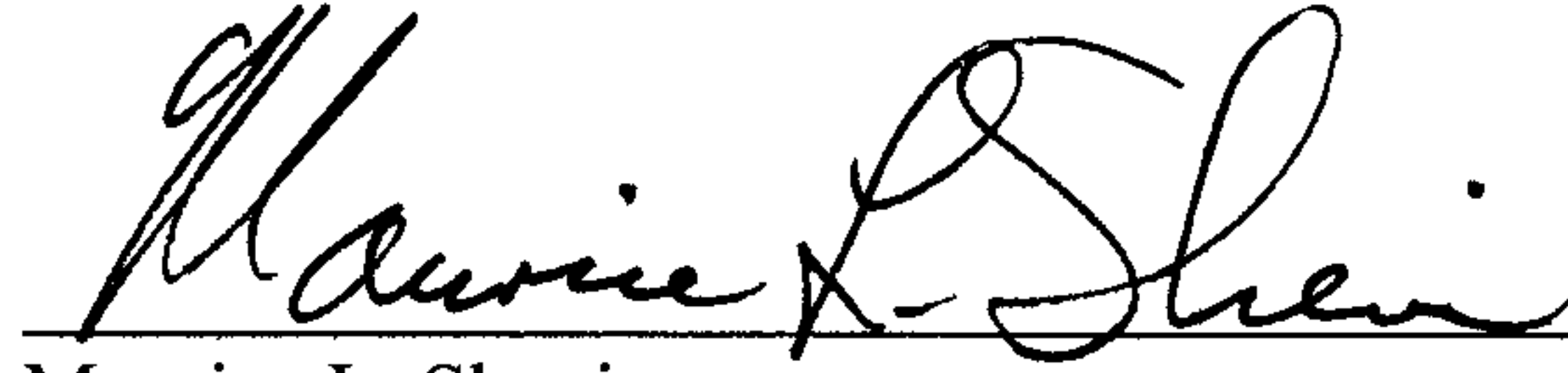
