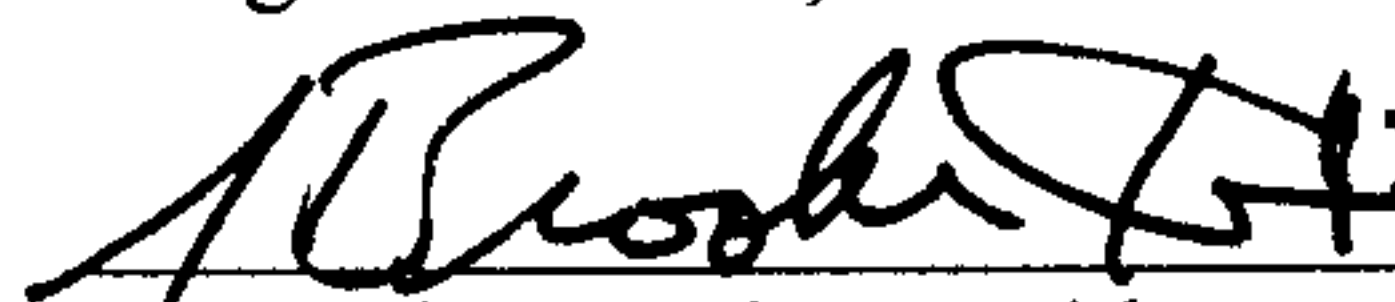
Schedule I
