MEMORANDUM OF LAND AND BUILDING LEASE AGREEMENT

THIS MEMORANDUM OF LAND AND BUILDING LEASE AGREEMENT ("Memorandum") is made and entered into this \(\frac{13}{12} \) day of \(\frac{1}{12} \) day of \(\frac{1}{12} \), 2009 by and between HILL/GRAY SEVEN, L.L.C., a Florida limited liability company ("Lessor") and BOJANGLES' RESTAURANTS, INC., a Delaware corporation ("Lessee").

WITNESSETH:

Lessor in consideration of the rents reserved that are hereinafter referred to, and of the terms, covenants and conditions on the part of Lessee that are hereinafter mentioned, does hereby demise and lease unto Lessee, and said Lessee does hereby take and hire from Lessor, all of that approximate one (1) acre tract located on the east side of U.S. Highway 31 (a/k/a Pelham Parkway) just south of its intersection with Southgate Estate MHP, in the City of Pelham, County of Shelby, State of Alabama ("Demised Premises"), and as more specifically described on Exhibit A which is made a part hereof, to have and to hold the said real property with the improvements thereon, and the appurtenances thereunto belonging.

TO HAVE AND TO HOLD the Demised Premises, together with the privileges and appurtenances thereunto pertaining for a term of fifteen (15) years pursuant to the terms of that certain LAND AND BUILDING LEASE AGREEMENT between the parties ("Lease Agreement"), upon the rents, terms, covenants and conditions contained in the Lease Agreement, all the provisions thereof being incorporated herein by reference.
