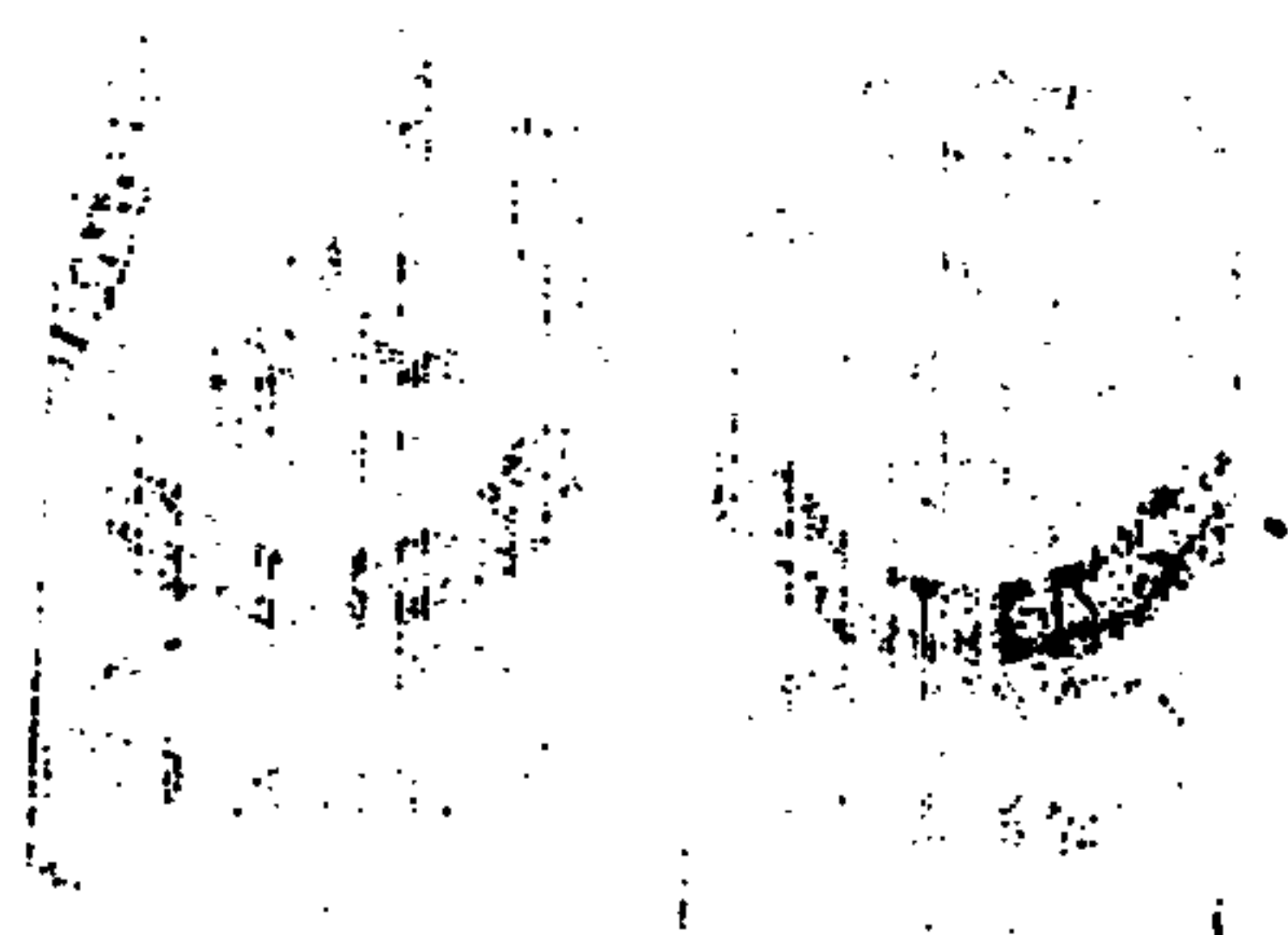

Purchaser agrees to pay to Glen Haven at the above address, the "Total of payments" indicated below (Line 7 of Disclosure Statement).

The first installment shall be payable on or before 5 APR 1989, and succeeding payments on or before the same date of each month thereafter until paid in full.

The Purchaser and Glen Haven agree further as follows:

- PERPETUAL CARE:** Glen Haven represents that under a trust agreement with the trust department of an authorized bank, as trustee, a trust fund has been established for the care and maintenance of the cemetery, grounds and improvements. The net income of the care and maintenance trust fund shall be used solely for the care and maintenance of the cemetery, for reasonable costs of administering such care and maintenance, and for reasonable costs of administering the trust fund.
- FAMILY PROTECTION PLAN:** If the person named above dies prior to the time this agreement is paid in full and the account is current, further payments hereunder to a maximum of \$1,000.00 of unpaid balance shall be excused, provided said person was under the age of 65 and in good health at the time this agreement is executed and is interred in Glen Haven. Protection does not apply when death is the result of suicide.
 - If at the time of need the Purchaser's property is in a pre-constructed facility Glen Haven Memorial Park, Inc. will transfer the Purchaser's property to a comparable developed garden or constructed facility AT NO INCREASE IN PRICE.
- DEFAULT:** In case of default for more than sixty (60) days in any of the payments herein provided, the Company may, at its option, declare this agreement null and void, and all payments made hereunder prior to default shall be retained as liquidated damages, and the Company may re-enter and repossess itself of such plots and/or merchandise and/or services, except as to any space and/or spaces where burial has been made with the consent of the Company, or the Company may, at its option, take legal action to enforce collection of any balance due and Purchaser hereby waives all rights of exemption as to personal property under the Constitution and Laws of this State, or any other State, and agrees to pay all costs of collection, including a reasonable attorney's fee, whether suit is filed or not. In the event Company elects to declare this agreement null and void all rights of purchaser are hereby terminated.
- ASSIGNMENT:** The Purchaser shall not assign its rights hereunder without the written consent of Glen Haven. Glen Haven may assign its rights hereunder.
- WARRANTY CONVEYANCE:** Upon payment of the total of payments in full, Glen Haven shall convey the rights of interment, inurnment or entombment described herein with full warranties, which rights shall be a license under the laws of the State of Florida.
- OPENING, CLOSING, FUNERAL DIRECTORS COSTS:** Opening and Closing costs are not included in this agreement unless specifically stated. No funeral directors charges are included.
- RULES:** The rights to be conveyed to the Purchaser shall, at all times, be subject to the general rules and regulations of Glen Haven as they may exist from time to time.
- ENTIRE AGREEMENT:** This instrument contains the entire agreement between the parties. It may be modified only by an instrument in writing executed by all parties.
- EFFECT:** This agreement shall bind the Purchaser, his heirs, assigns and personal representatives and the successors and assigns of Glen Haven. The undersigned hereby waive presentment, demand, notice of dishonor and protest and agree that should it become necessary to employ the services of an attorney to enforce the terms hereof, to pay the costs of collection hereof including 15% of the unpaid balance as a reasonable attorney's fee. If any installment agreed to be paid by the buyer is not paid within 10 days of its due date, buyer shall pay to seller a delinquency charge of 5% of each such installment or \$5.00, whichever is less.

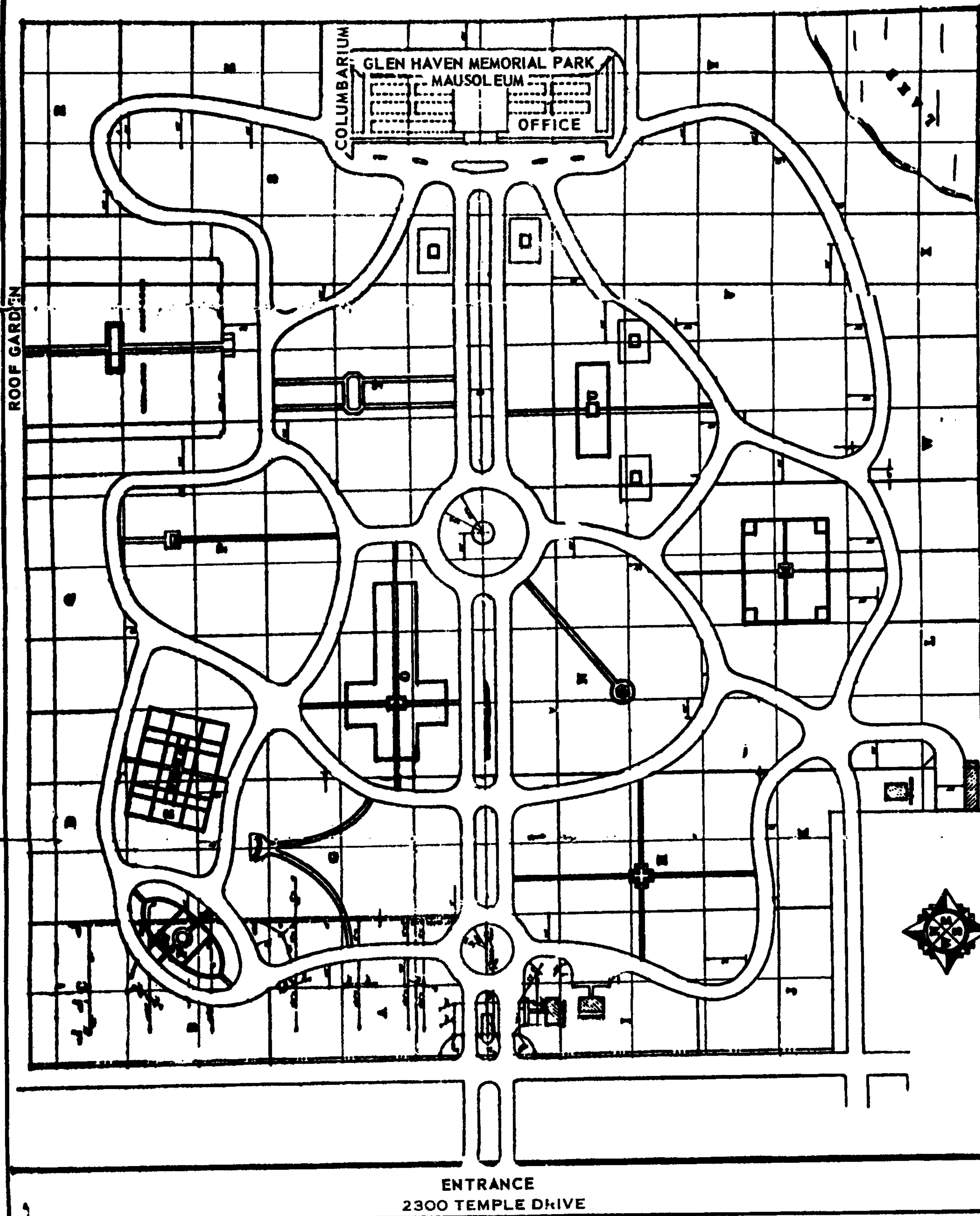

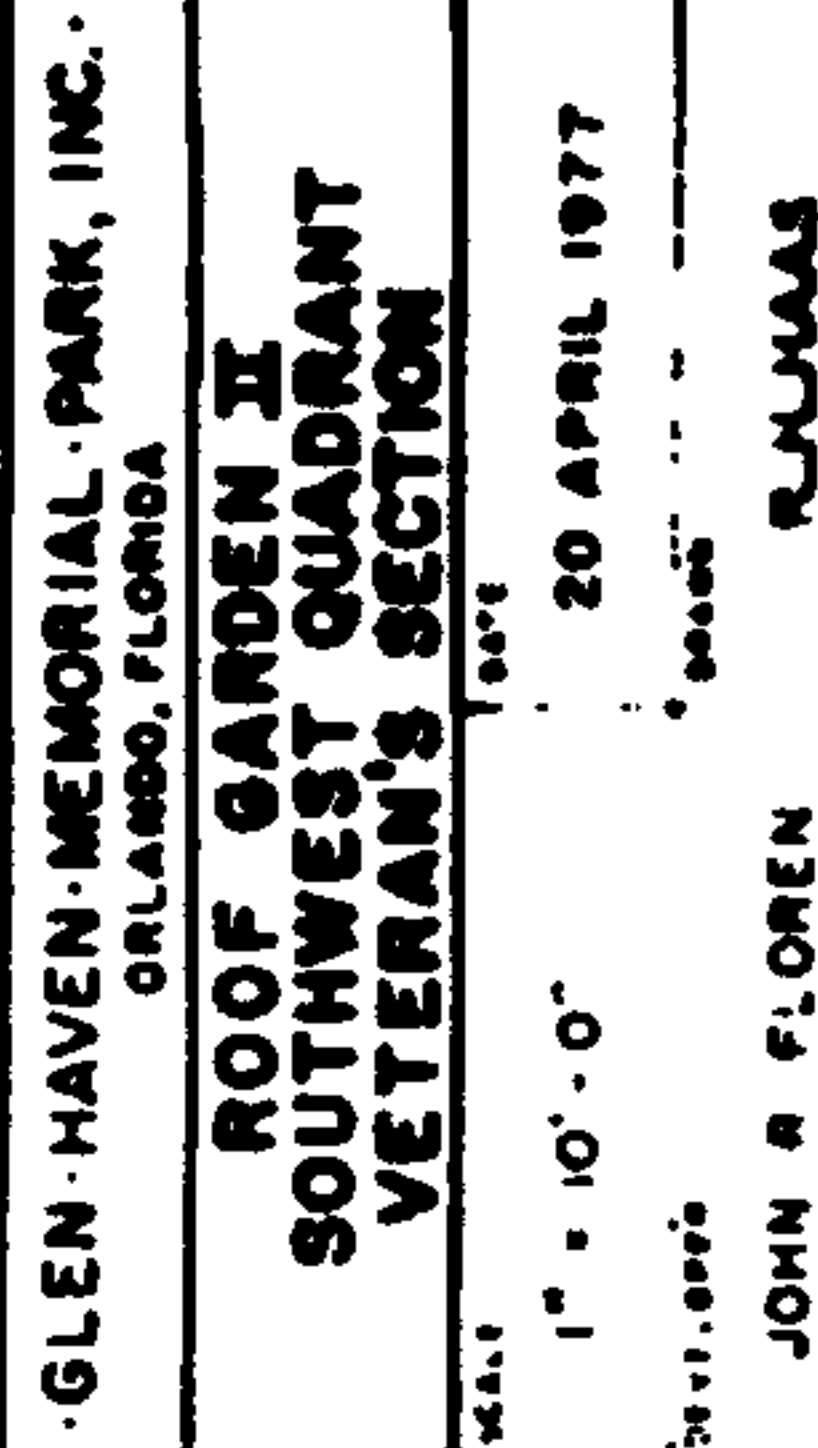
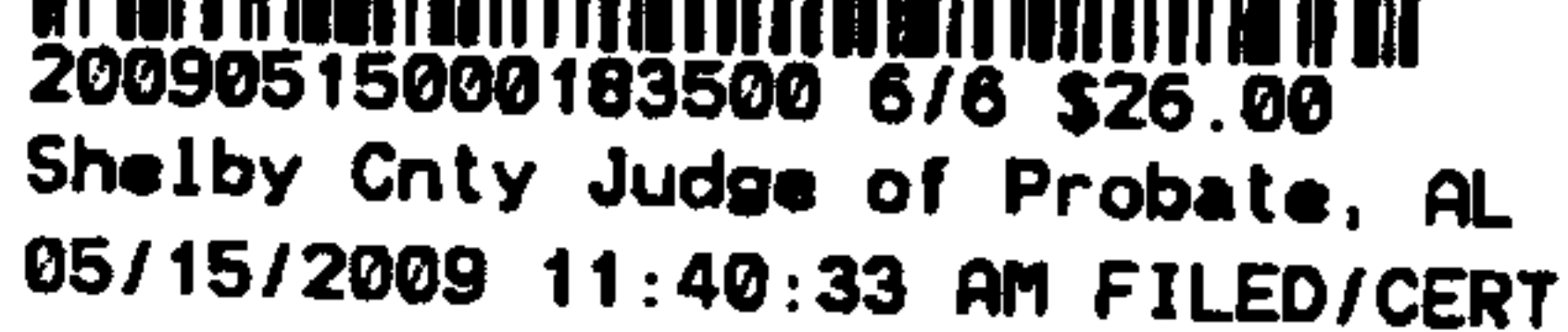
