

LIMITED POWER OF ATTORNEY TO EXECUTE DOCUMENTS


FANNIE MAE, a corporation organized and existing under the laws of the United States of America, having an office for the conduct of business at 14221 Dallas Parkway, Suite 1000, Dallas, Texas 75254, constitutes and appoints McFadden, Lyon & Rouse, LLC, organized under the laws of the State of Alabama, with an office for the conduct of business at 718 Downtowner Boulevard, Mobile, Alabama 36609, as its true and lawful Attorney-in-Fact, and in its name, place, and stead and for its use and benefits, to do all things, and execute all documents, necessary and appropriate to conduct, or vacate, foreclosure proceedings in the State of Alabama and, further, to execute, endorse, and acknowledge all documents customary and reasonably necessary and appropriate for the escrow or closing of sales and the conveyance of real properties owned by Fannie Mae in the State of Alabama. Such powers shall include, but are not limited to, the following:

- 1. Deeds transferring the real property and improvements owned by Fannie Mae;
- 2. Settlement/Closing Statements;
- 3. Affidavits and Indemnifications as to Debts and Liens;
- 4. Tax Proration Agreements;
- 5. Seller's Affidavits and Agreements;
- 6. Errors and Omissions Correction Agreements;
- 7. Entry of bid at a foreclosure sale;
- 8. Assignment, or acceptance of an assignment of a foreclosure bid;
- 9. Execution of any other approved document as directed by Fannie Mae.


