JUDGMENT

By prior order, the defendants were given until May 5, 2009, to file a response to the plaintiff's summary judgment motion. The defendants have filed nothing by that deadline, however, so the Court must assume that the facts stand undisputed.

Based on the undisputed facts, the Court finds that the plaintiff is entitled to a judgment as a matter of law. The following is therefore ORDERED:

JUDGMENT in the amount of \$41,275.89, plus court costs, is hereby entered in favor of the plaintiff and against the defendants, who shall be jointly and severally liable therefor.

Additionally, the plaintiff is entitled to possession of the following items of collateral:

One 2006 24-foot car hauler, VIN # 4ZECF202X61020215  
One 2001 40-foot trailer, VIN # 5BNFG40231C009534  
One 1998 International 4900, VIN # 1HTDSAANXWH538697  
One 1996 Chevrolet C1500, VIN 2GBEC19R1T1110329

A Writ of Possession may be issued to the Sheriff of Jefferson County, Alabama, for the execution of such writ and the recovery of this property. No defendant, nor anyone working with or for any of the defendants, shall dispose of or alter in any form the vehicles described above. If the defendants or their agents do dispose of or alter any of these vehicle in contravention of this order, they will be subject to punishment for contempt of Court.

In the event that the plaintiff recovers possession of any of the vehicles described above, it shall undertake to sell such vehicles in a commercially reasonable manner in accordance with the obligations under law and under any contractual provisions that might apply. The net proceeds of any sale shall be used to reduce the judgment indebtedness of the defendants.
