KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of Two Hundred Fifty-Five Thousand Nine Hundred Ninety and 00/100 (\$255,990.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTORS, **Arthur W. Smith, III and Sherry Smith, husband and wife** (hereinafter referred to as GRANTORS), the receipt whereof is hereby acknowledged, the GRANTORS do hereby give, grant, bargain, sell and convey unto the GRANTEES, **Bethany A. Freeman and Clint A. Sweatt, wife and husband**, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:

Lot 442, according to the Survey of Grande View Estates Givianpour Addition to Alabaster, 4th Addition, as recorded in Map Book 21, Page 100 A & B, in the Probate Office of Shelby County, Alabama. Mineral and mining rights excepted.
