





Know All Men by These Presents: That in consideration of One hundred seventy four thousand one hundred and no/100 (\$174,100.00) to the undersigned grantor, in hand paid by the grantee herein, the receipt where is acknowledged, I/We, Angeline Heather Swindle, as Executrix of the Estate of John Charles Dorsett, Probate Case No. PR2007-000143 (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto Cynthia L.
