

**Articles of Organization  
for  
P & L Painting & Drywall, L.L.C.**

The undersigned, for the purpose of originating P & L Painting & Drywall, L.L.C. as a limited liability company (the "Company") pursuant to the provisions of the Alabama Limited Liability Company Act (the "Act"), does hereby adopt the following Articles of Organization:

**ARTICLE I**

The name of the Company is P & L Painting & Drywall, L.L.C.

**ARTICLE II**

The existence of the Company shall commence June 3, 2009, and shall continue perpetually; provided, however, that the Company shall be dissolved prior to such date upon the earlier to occur of (i) the written consent of all the members to dissolve the Company; (ii) as provided in the Operating Agreement of the Company; or (iii) as may be required under the Act.

**ARTICLE III**

The nature of the business to be conducted or promoted or the purposes of which the Company is organized is to engage in any or all lawful business for which limited liability companies maybe organized under the Act and the laws of Alabama, as the same now exist or may hereafter be amended. Specifically, but not limited to, P & L Painting & Drywall, L.L.C. will engage in the business of providing construction labor, materials, and services.

The foregoing clauses shall be construed as purposes for which the Company is organized, in addition to those powers specifically conferred upon the Company by law, and it is hereby expressly provided that the foregoing specific enumeration of powers shall not be held to limit or restrict in any manner the powers of the Company otherwise granted by law.

#### **ARTICLE VII**

The Company shall admit additional members only upon the terms and conditions set forth in the Operating Agreement of the Company.

#### **ARTICLE VIII**

The cessation of membership in the Company of one or more members will result in dissolution of the Company if there are no remaining members, unless the legal existence and business of the Company is continued and one or more new members are appointed in the manner provided in the Company's Operating Agreement.

#### **ARTICLE IX**

The Company shall be managed by Wilfredo Lopez, the Managing Member.

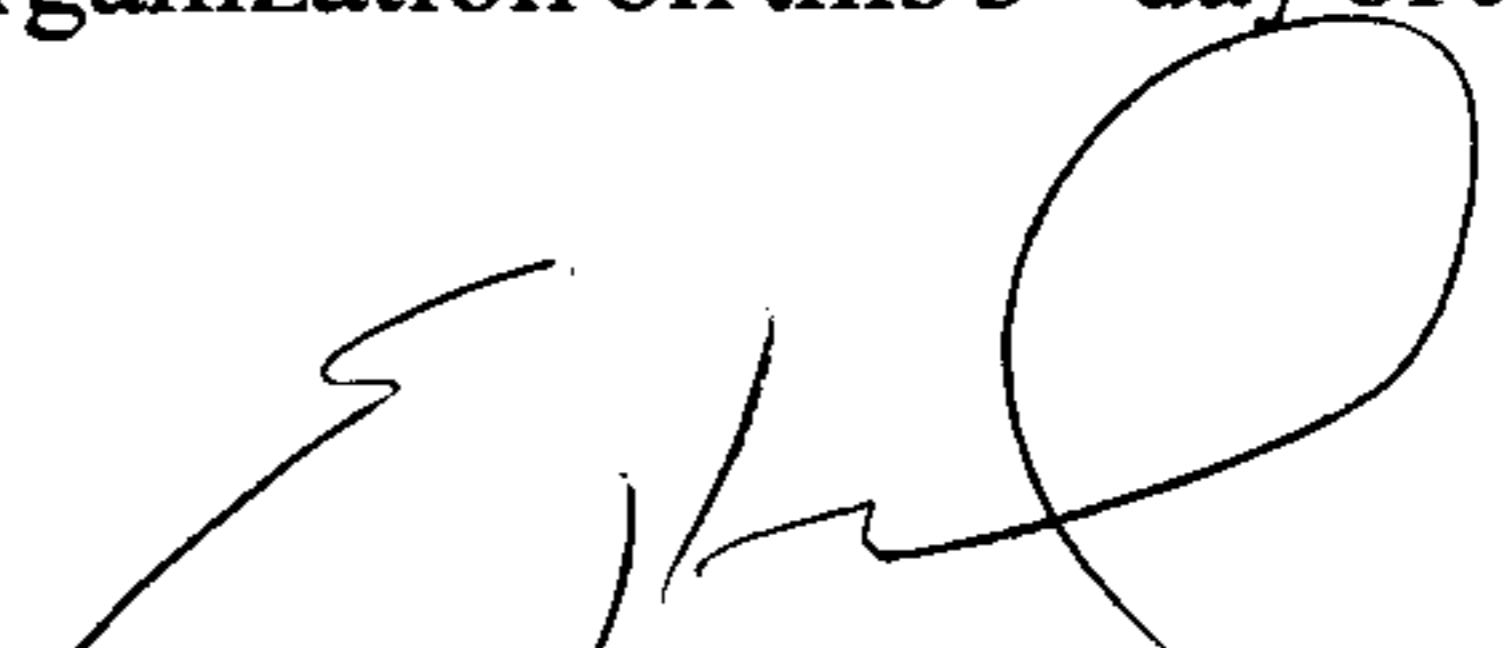
