**ARTICLES OF ORGANIZATION
OF
BIG SHOWOFFS, LLC
An Alabama Limited Liability Company**

Pursuant to the provisions of Sections 10-12-1, *et seq.* of the Code of Alabama (1975), the undersigned hereby adopts the following Limited Liability Company Articles of Organization.

ARTICLE I

Name

The name of the limited liability company is Big Showoffs, LLC, an Alabama Limited Liability Company (the "Company").

ARTICLE II

Duration

The Company shall have duration from the date of organization until it is dissolved and its affairs wound up in accordance with the Alabama Limited Liability Company Act (the "Act").
