
# ARTICLES OF INCORPORATION

#### KNOW ALL PERSONS BY THESE PRESENTS,

That I, Guy A. Colle, the undersigned incorporator, for the purpose of forming a business corporation pursuant to the provisions of the Alabama Business Corporation Act, do hereby adopt these articles of incorporation, the same to constitute a charter for carrying on the business hereinafter specified.

## SECTION 1. NAME OF CORPORATION

The name of the corporation shall be Cahaba Machine Design, Inc.

### SECTION 2. PURPOSES

The nature of the business and the purposes for which the corporation is formed shall be as follows:


#### 2.1 Specific Purpose.

The duration of the corporation shall be perpetual unless the corporation is dissolved by law or otherwise terminated.

## SECTION 5. SHARES

The corporation shall be authorized to issue 100 common shares having a par value of \$1.00 per share.

#### SECTION 7. DIRECTORS



## SECTION 9. MANAGEMENT


The business and affairs of the corporation shall be managed and conducted in accordance with the bylaws of the corporation.
