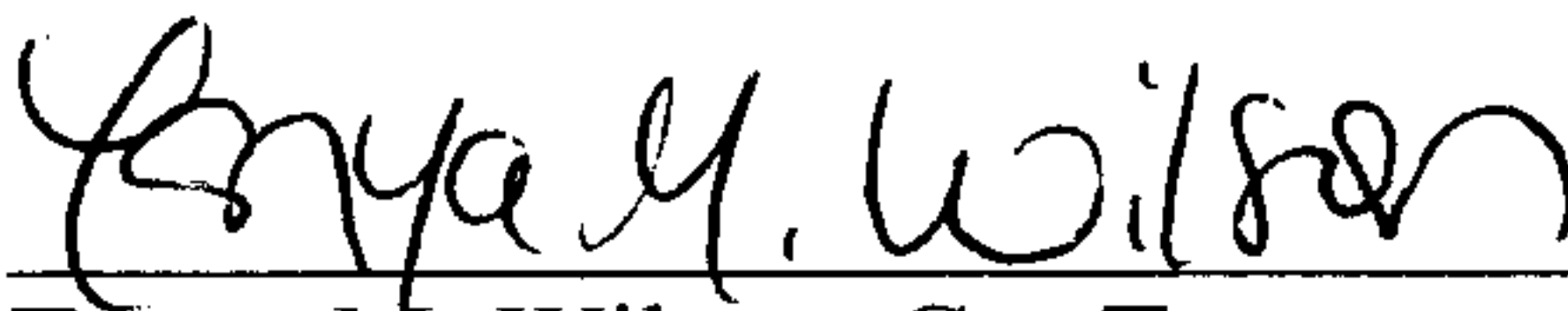

1. There is a valid and existing trust, having been created by the Mark A. Wilson and Tanya M. Wilson Joint Living Trust dated May 6, 2004.

 - A. The original settlor(s) and successor settlor(s), if any, of the trust was:

 - B. The following person(s) contributed money, funds, real property, or personal property to the trust:

 - C. The original trustees were:

 - D. The names and addresses of the currently acting co-trustee(s):

 - F. Mark A. Wilson and Tanya M. Wilson Joint Living Trust dated May 6, 2004 has definite beneficiaries. The named beneficiaries are not the sole trustee and sole beneficiary.
 - G. While both of the Trustors are living, each of the original Co-Trustees has the power acting alone to bind the Trust in any transaction and may be the sole signatory on any documents to accomplish such transaction. While both of the Trustors are living, if either Trustor fails or ceases to serve as Trustee, then the other Trustor shall serve as sole Trustee. If both Trustors become unable or unwilling to serve as Trustee, Catherine Wilson of Hoboken, New Jersey shall serve as successor Co-Trustees of all trusts created by the Trust Agreement. If Catherine Wilson is or becomes unable or unwilling to serve as Co-Trustee, then Joseph Wilson, of North Myrtle Beach, South Carolina is designated as the alternate successor Trustee, without bond.
3. The administrative and/or managerial powers of the trustee are:
Pursuant to the powers granted to the trustees in the Certificate of Trust Establishment and Trustee Authority and California Probate Code Section 18100.5(f), this Certificate may be relied upon by anyone dealing with the Trustors and the Trustees of the Trust as evidence of the establishment of the Trust and the authority of the Trustee. Under the provisions of the Trust, the Trustee has

- broad trust powers, including the power to invest and reinvest the Trust Estate in property, real, personal, or mixed, the power to buy and sell Trust property, the power to lease trust real property, the power to employ agents and advisors, the power to borrow money, and the power to exercise all the rights of an owner with respect to securities.
4. The Trust is revocable.
 5. The following trustees have the authority to sign documents and instruments:
Mark A. Wilson and Tanya M. Wilson, as Co-Trustees.
 6. Trust Property should be titled as follows:
Mark A. Wilson and Tanya M. Wilson, as trustees of the Mark A. Wilson and Tanya M. Wilson Joint Living Trust dated May 6, 2004.
 7. To the best of the undersigned's knowledge, the trust has not been revoked, modified, or amended in any manner that would cause the representations and statements contained herein to be incorrect.
 8. No person or entity paying money to or delivering property to my Trustee shall be required to see its application. All persons relying on this document regarding the Co-Trustees and their powers over trust property shall be held harmless for any resulting loss or liability from such reliance. A Copy of this Certificate of Trust shall be just as valid as the original.
