

## ARTICLES OF ORGANIZATION OF ADCOCK PROPERTIES, LLC

For the purpose of forming a limited liability company under the Alabama Limited Liability Company Act and any act amendatory thereof, supplementary thereto or substituted therefor (hereinafter referred to as the "Act"), the undersigned does hereby sign and adopt these Articles of Organization, and, upon filing for record of these Articles of Organization in the Office of the Judge of Probate of Shelby County, Alabama the existence of a limited liability company (hereinafter referred to as the "Company"), under the name set forth in Article 1 hereof, shall commence.

### ARTICLE 1

#### NAME

1.1 The name of the Company shall be Adcock Properties, LLC.

### ARTICLE 2

#### PERIOD OF DURATION

2.1 The duration of the Company shall be perpetual.

### ARTICLE 3

#### PURPOSES, OBJECTS AND POWERS

- (b) To carry on any and all aspects, ordinary or extraordinary, of any lawful business and to enter into and carry out any transaction, ordinary or extraordinary, permitted by law, having and exercising in connection herewith all powers given to companies by the laws of the State of Alabama.

### ARTICLE 4

#### REGISTERED OFFICE AND REGISTERED AGENT

4.1 The location and mailing address of the initial registered office of the Company shall be 4018 Highland Ridge Road, Birmingham, AL 35242.

4.2 The initial registered agent at such address shall be Lamar D. Adcock.
