Pursuant to the Provisions of Act No. 93-724 of the 1993 Alabama Legislature and Act No. 97-920 of the 1997 Alabama Legislature (Title 10, Chapter 12, Code of Alabama, 1975), the undersigned hereby adopt the following Limited Liability Company Articles of Organization:

ARTICLE I

The Name of The Limited Liability Company is:

ARTICLE II

DURATION

Unless terminated sooner by unanimous agreement of the members or by a provision of the operating agreement or a provision under the Alabama Limited Liability Company Act, the limited liability company known as **HIS PLACE PROPERTIES, LLC** duration will be perpetual.

ARTICLE III

PURPOSES

The Limited Liability Company has been organized for the following purposes:

(A) To buy, sell, rent and/or maintain real estate; and for any other purpose incident or necessary thereto;

(B) To maintain an establishment and conduct its business and promote its objectives within and without the State of Alabama and other states, without restriction as to amount and place; in general, to carry on any other business in connection therewith, not forbidden by the laws of the State of Alabama, and to have all other powers conferred upon Limited Liability Companies by the laws of the State of Alabama.
