KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 23rd day of May, 2006, Rogers L. Walker, a married man and Lucretia J. Walker, a married woman, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for Reserve Mortgage Investments, LLC, a Texas Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 20060605000263670, said mortgage having subsequently been transferred and assigned to CitiMortgage, Inc., by instrument recorded in Instrumnet No. 20070117000023880, in the aforesaid Probate Office ("Transferee"); and

Lot 24, according to the Survey of Marengo Sector One, as recorded in Map Book 22, Page 123, in the Probate Office of Shelby County, Alabama.

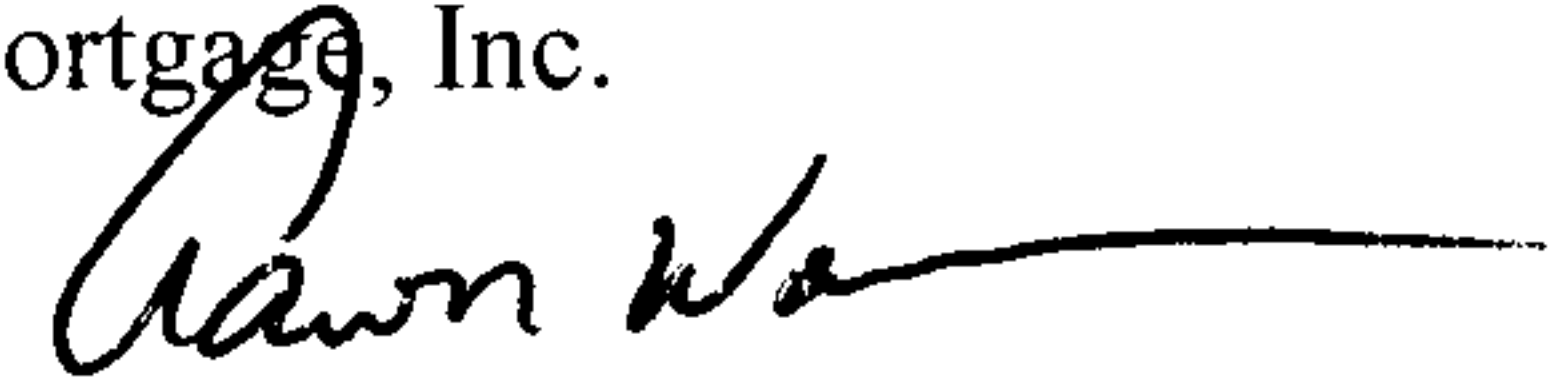

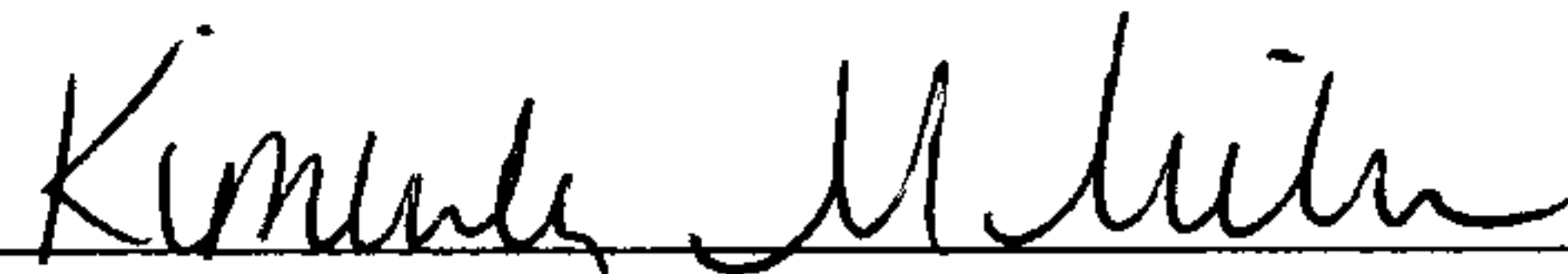
