
**ARTICLES OF ORGANIZATION

Pursuant to the provisions of Sections 10-12-1, *et seq.* of the Code of Alabama (1975), the undersigned hereby adopts the following Limited Liability Company Articles of Organization.

ARTICLE I

Name

The name of the limited liability company is JJK ENTERPRISES, LLC, an Alabama Limited Liability Company (the "Company").

ARTICLE II

Duration

Cessation of Membership

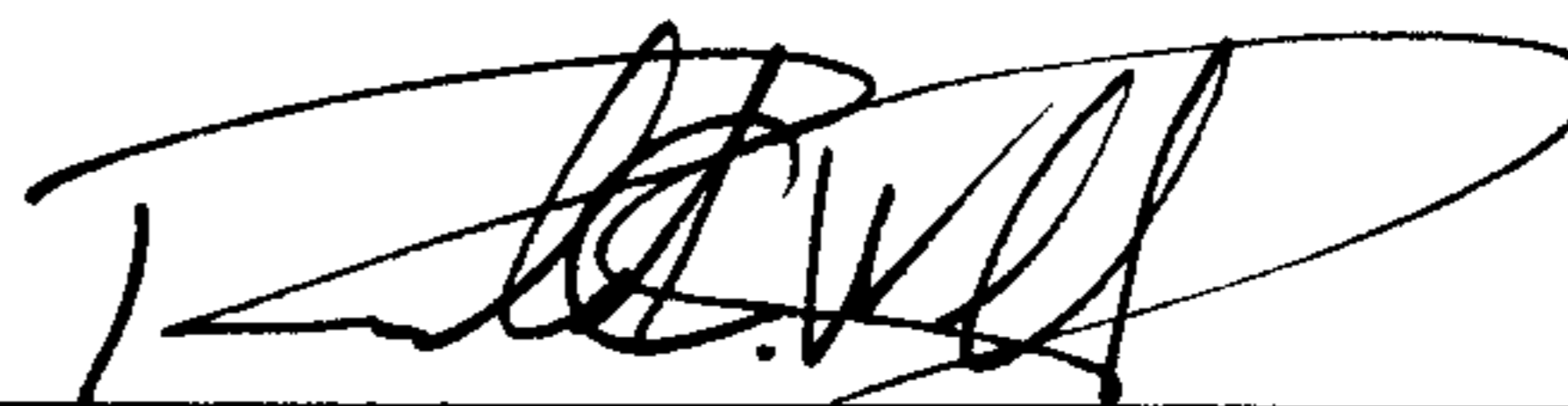
The cessation of membership of one or more members will not result in the dissolution of the Company.
