**Amendment to the  
The Articles of Organization of

Pursuant to the Provisions of Code of Alabama § 10-12-1 et seq. (1975), known as the “Alabama Limited Liability Company Act,” the undersigned hereby amend and adopt the following Limited Liability Company Articles of Organization as of the 14th day of May, 2009.

**ARTICLE I**

**Name of Limited Liability Company**

The name of the limited liability company shall be **Family Wellness Chiropractic, LLC** (the “Company”).

**ARTICLE II**

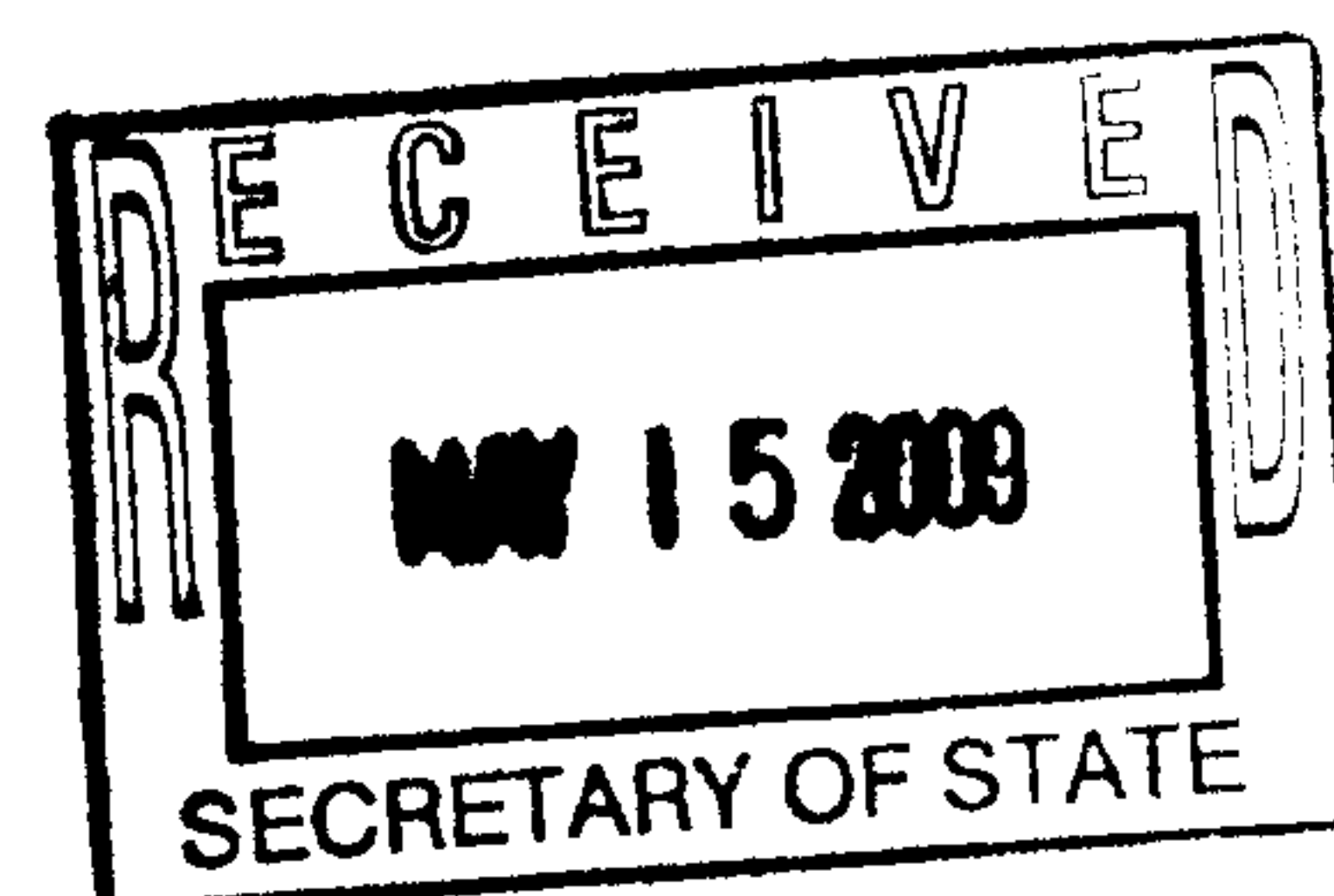
**Period of Duration**

forth in the Company's Operating Agreement.


