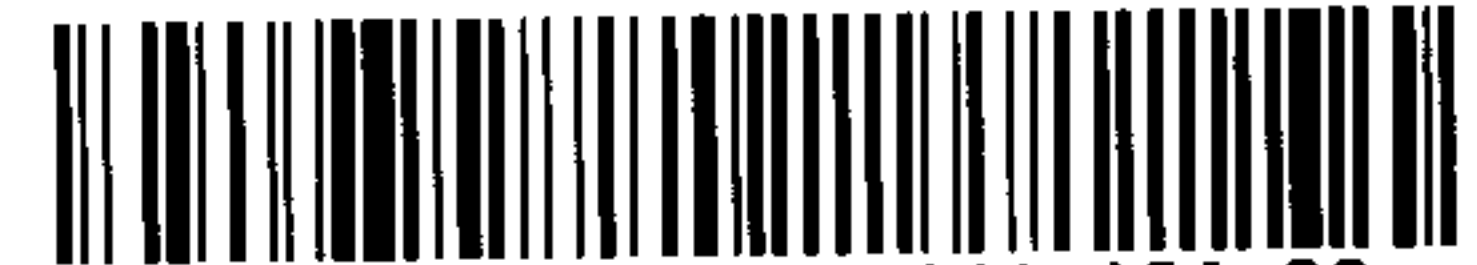

IN WITNESS WHEREOF, the Grantor has caused this instrument to be executed by its duly authorized representative on this the 21st day of April, 2009.


