
## SUBORDINATION AGREEMENT



The undersigned, Merchants & Farmers Bank is the holder and owner of a lien made by Roy J. Frazier II and Lynn S. This and Subordination Agreement shall be binding upon the heirs and assigns of Merchants & Farmers Bank , and shall operate to the benefit of the grantee in the First Mortgage, the successors and assigns of said grantee, and of any purchaser at any foreclosure sale thereunder, and shall apply with like force and effect to any renewal thereof.
