THIS FORECLOSURE DEED made this 9<sup>th</sup> day of June, 2009, between PAUL W. SOMMERS and AMY S. SOMMERS, husband and wife, Party of the First Part, and BANK OF AMERICA, NATIONAL ASSOCIATION AS SUCCESSOR BY MERGER TO LASALLE BANK NATIONAL ASSOCIATION, AS TRUSTEE FOR CERTIFICATEHOLDERS OF BEAR STEARNS ASSET BACKED SECURITIES I LLC ASSET BACKED CERTIFICATES, SERIES 2004-HE10, Party of the Second Part;

W I T N E S S E T H:

WHEREAS, the said PAUL W. SOMMERS and AMY S. SOMMERS, husband and wife, heretofore executed to MORTGAGE ELECTRONIC REGISTRATION SYSTEMS, INC. ("MERS") Solely as nominee for Lender and Lender's successors and assigns, herein called the Mortgagee, a certain mortgage dated June 30, 2004 and recorded in Instrument Number 20040729000421390, Probate Records of Shelby County, Alabama, which conveyed the hereinafter described property to secure the indebtedness evidenced by a note, payable in installments, therein described; and
