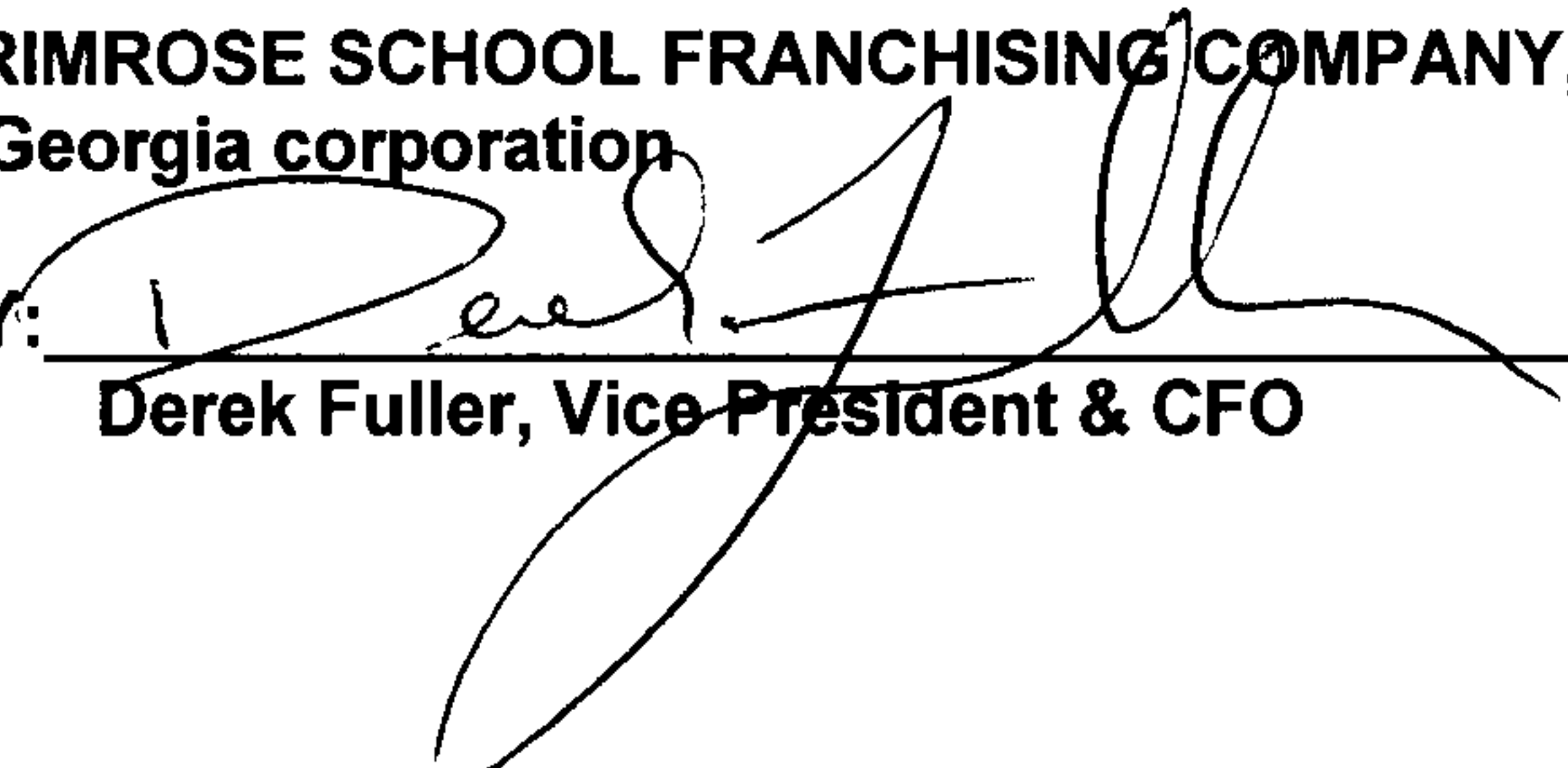
Grantees shall pay the ad valorem tax due October 1, 2009.
