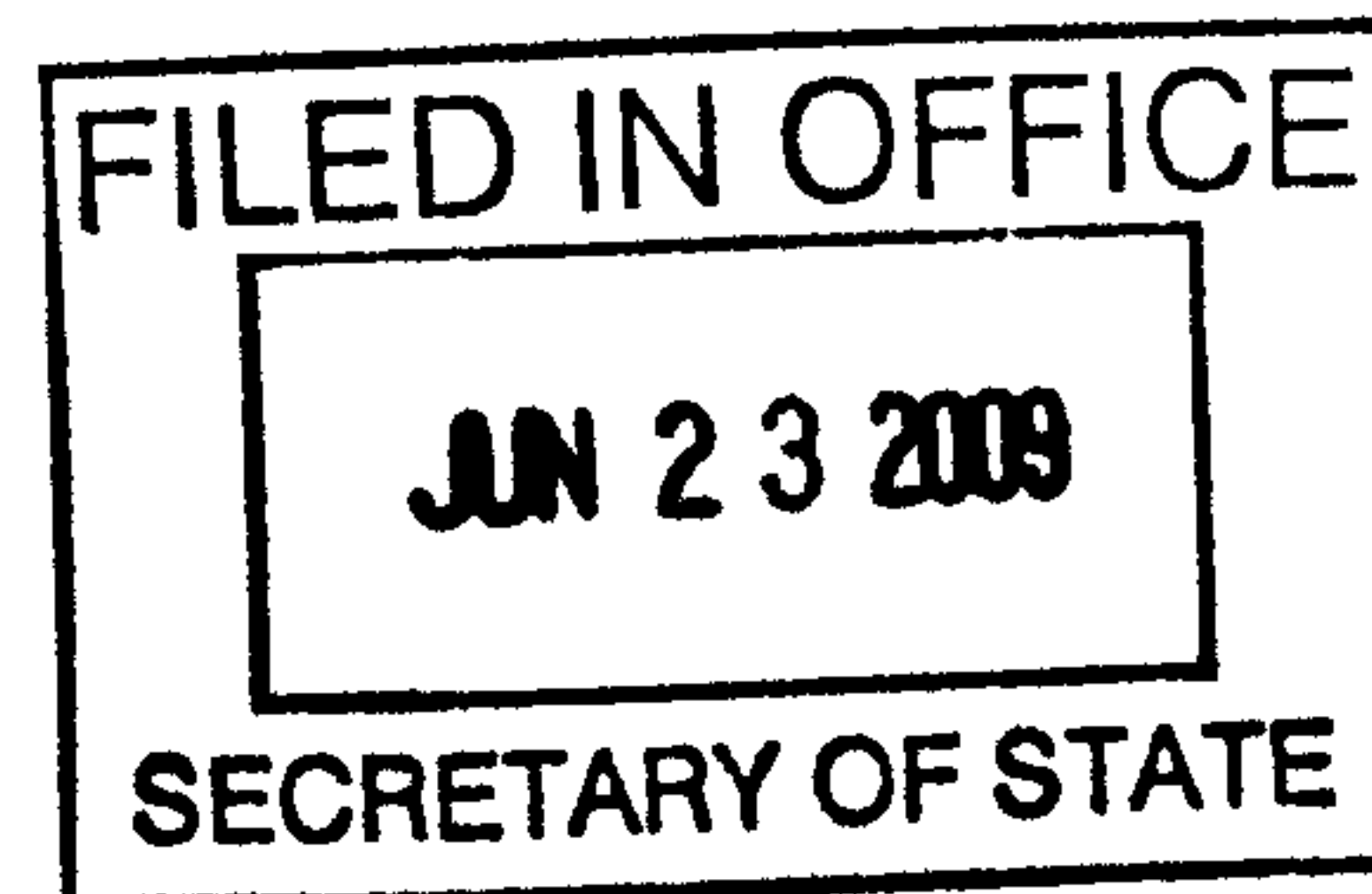

8. A copy of the plan of merger will be furnished by the surviving or resulting business entity, on request and without cost, to any equity owner of any business entity, which is a party to the merger.

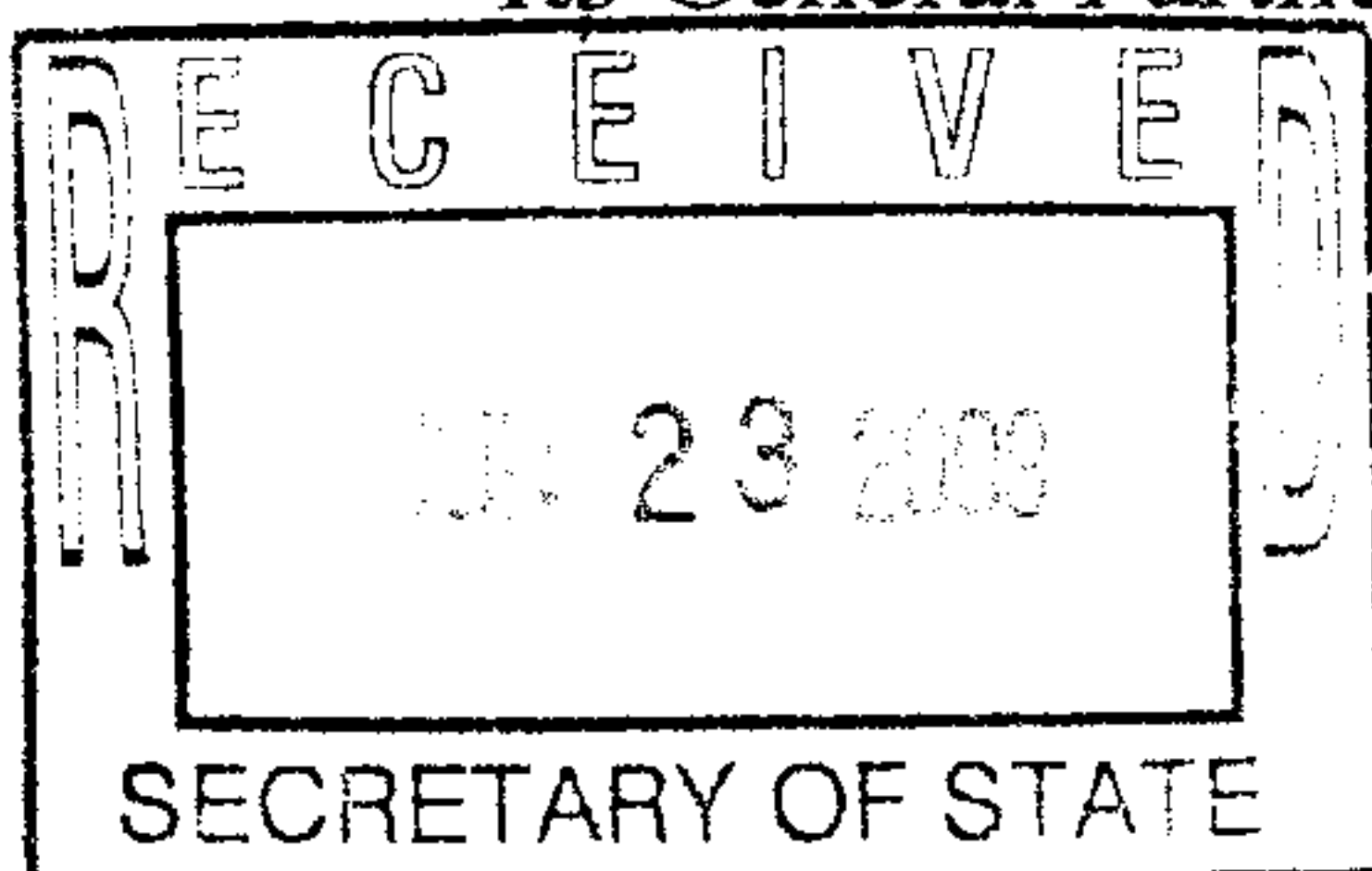
