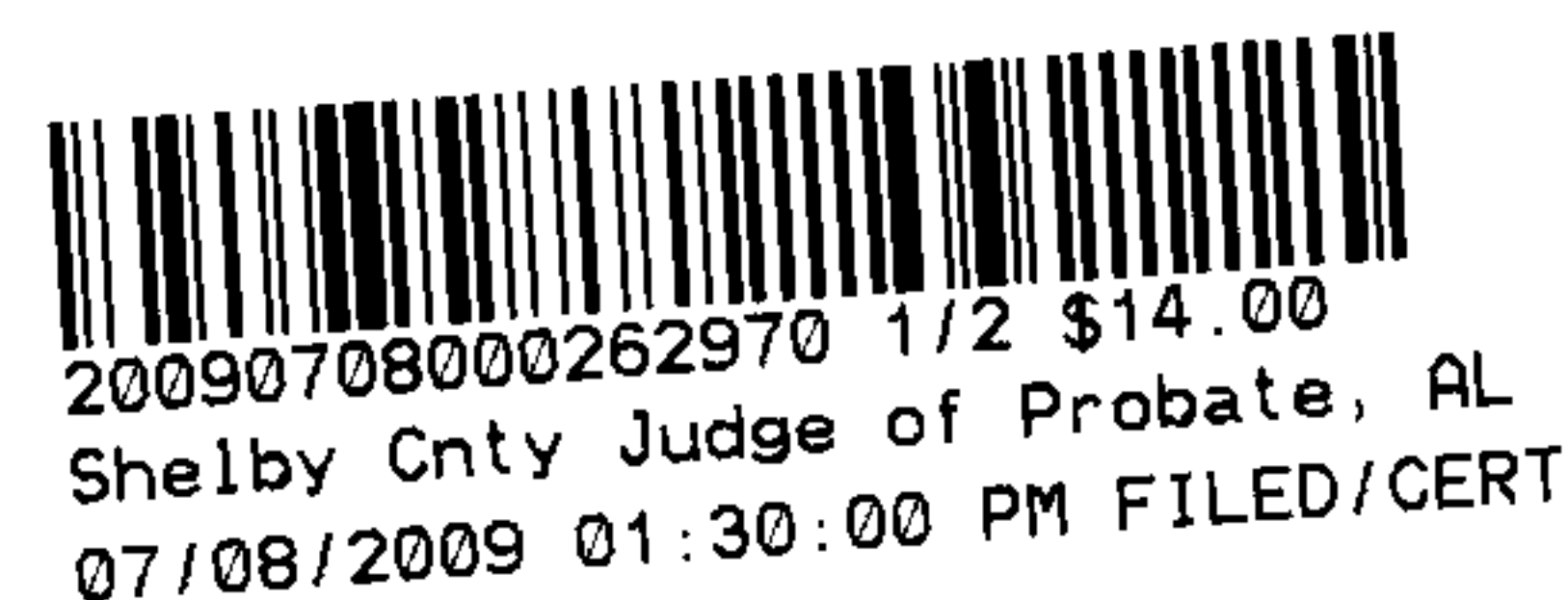

**PARTIAL RELEASE**

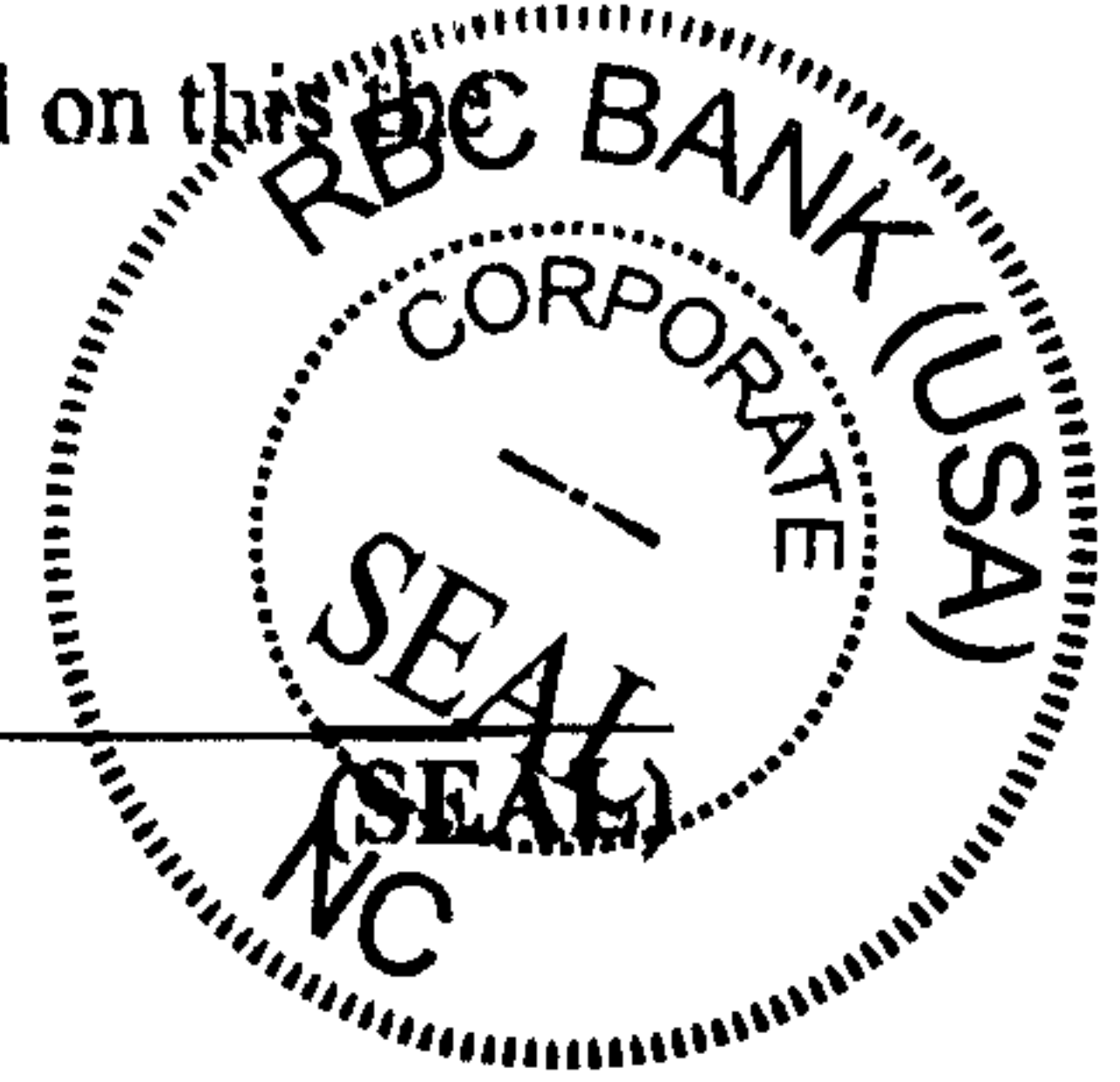

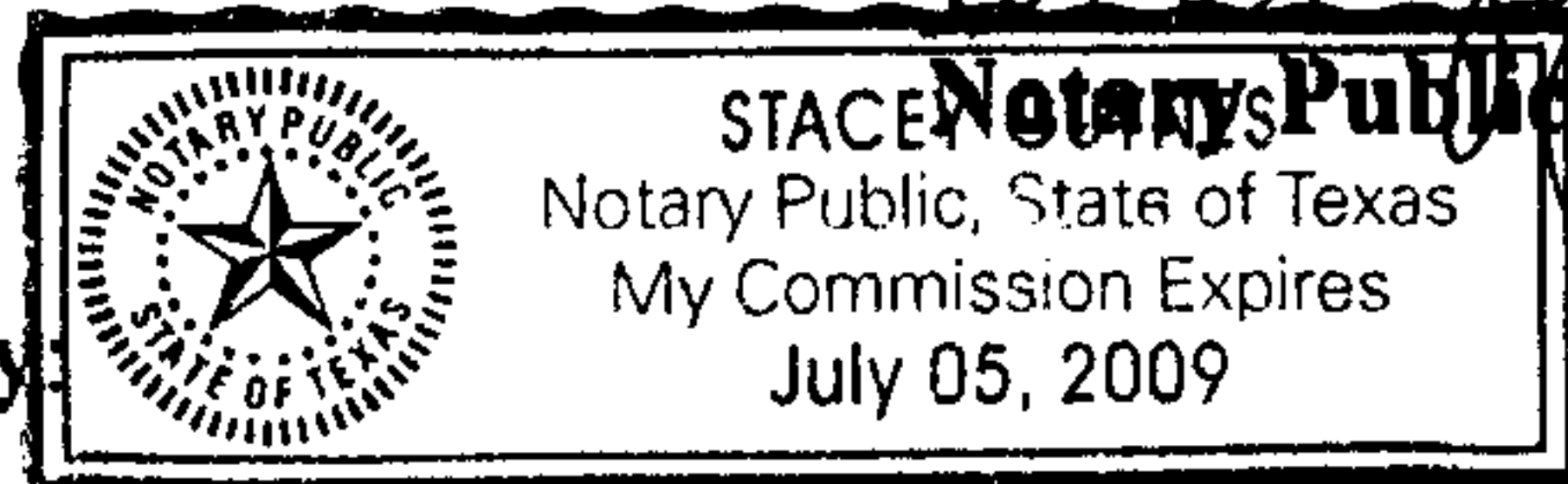
