KNOW ALL PERSONS BY THESE PRESENTS,

That I, Keith E. Kelley, the undersigned incorporator, for the purpose of forming a business corporation pursuant to the provisions of the Alabama Business Corporation Act, do hereby adopt these articles of incorporation, the same to constitute a charter for carrying on the business hereinafter specified.

SECTION 1. NAME OF CORPORATION

The name of the corporation shall be Kelley Builders & Designers, Inc.

SECTION 2. PURPOSES

The nature of the business and the purposes for which the corporation is formed shall be as follows:

2.1 Specific Purpose.


To transact all lawful business for which corporations may be incorporated under the Alabama Business Corporation Act.

SECTION 3. REGISTERED OFFICE AND AGENT

The address of the initial registered office of the corporation shall be 224 River Oaks Drive, Helena, AL 35080, and the initial registered agent at such address shall be Keith E. Kelley.

SECTION 4. DURATION

The duration of the corporation shall be perpetual unless the corporation is dissolved by law or otherwise terminated.

SECTION 5. SHARES

The corporation shall be authorized to issue 1000 common shares having a par value of \$1.00 per share.

SECTION 6. INCORPORATOR


SECTION 9. MANAGEMENT
