Subject to existing easements, current taxes, restrictions and covenants, set-back lines and rights of way, if any, of record.


\$ 587,000.00 of the above recited purchase price was paid from a mortgage loan closed simultaneously herein.

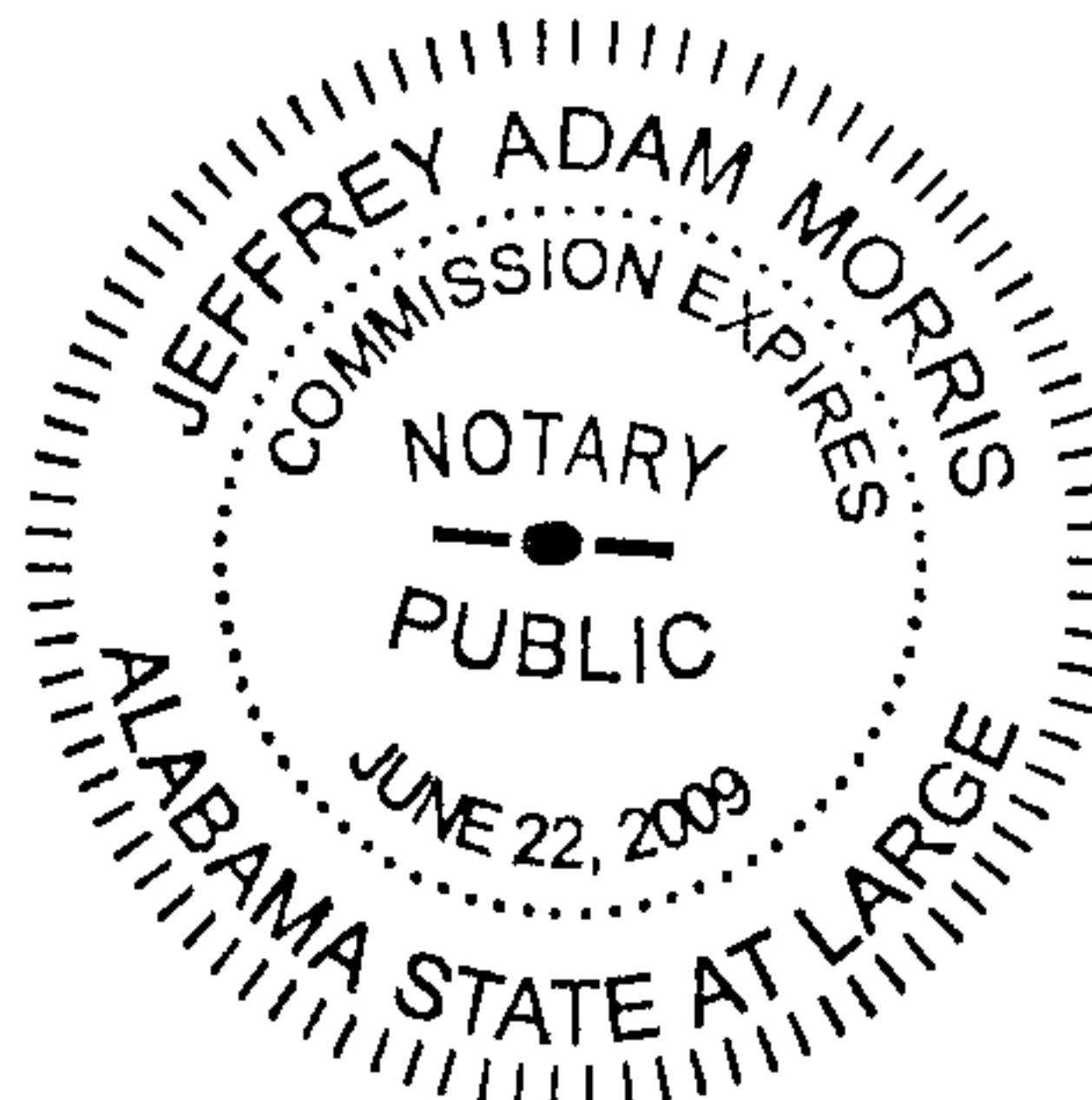
