KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of Ten and No/100 Dollars (\$10.00) to the undersigned Grantors, in hand paid by the Grantees herein, the receipt whereof being hereby acknowledged, **JAMES KENNETH JONES and wife, MARTHA W.
