ORDER

THIS CAUSE coming on to be heard on Plaintiff Jenkins Brick Company's Application and Affidavit for Entry of Default Judgment, and the Defendants Thompson Contracting & Investments, Inc. and Jeff Thompson having been served on March 31, 2009, but failing to appear or otherwise defend this action, upon the affidavit of the Plaintiff and for good cause being shown, it is therefore ORDERED, ADJUDGED, AND DECREED by the Court as follows:

1. That a money judgment is hereby entered in favor of the Plaintiff, Jenkins Brick Company, and against the Defendants Thompson Contracting & Investments, Inc. and Jeff Thompson, in the amount of \$8,716.19, which said judgment is composed of \$7,059.64 in principal, \$656.55 in interest, and \$1,000.00 in attorney's fees, which are recoverable pursuant to the Contract entered into between Defendants Thompson Contracting & Investments, Inc. and Jeff Thompson and Plaintiff Jenkins Brick Company.

2. That the materialman's lien recorded on March 10, 2009, which was recorded at Instrument number 20090310000087290, in the Office of the Judge of Probate of Shelby County is hereby perfected and is hereby affixed and established as of December 31, 2008, the first date work or materials were supplied to the real property set forth below, in the amount of \$8,716.19 on all the right, title and interest of the Defendant Thompson Contracting & Investments, Inc. in the following described real property:

Lot 8, according to a Resurvey of Lots 1-24 and 27-39, The Grove, as recorded in Map Book 36, page 97, in the Probate Office of Shelby County, Alabama.


3. Furthermore, the Court hereby orders that the above-described real property be condemned and sold in satisfaction of the aforesaid Lien herein established. See Ala. Code § 35-11-224.
