

## AMENDMENT TO MORTGAGE

This Amendment to Mortgage if effective as of the 15<sup>th</sup> day of November, 2008, between **COMPASS BANK**, an Alabama banking corporation (the "Lender"), and **BENT RIVER**, LLC, an Alabama limited liability company (the "Borrower").


WHEREAS, in connection with a loan from Lender to Borrower in the original principal amount of \$8,500,000.00 (the "Loan"), Borrower executed and delivered to Lender, among other documents (collectively, the "Loan Documents"), the following documents dated November 30, 2006: (i) Promissory Note in the amount of \$8,500,000.00 (the "Note"), (ii) Construction Loan Agreement (the "Loan Agreement"); and (iii) Future Advance Mortgage, Assignment of Rents and Leases, and Security Agreement (Alabama), recorded at Instrument Number 20061201000583530, in the Probate Office of Shelby County, Alabama (as amended, the "Mortgage"); and

WHEREAS, Borrower and Lender have amended the Note to increase the amount of the Loan by an additional \$788,704.24, so that the total amount of the Note secured by the Mortgage is now \$9,288,704.24; and

WHEREAS Borrower and Lender desire to amend the Mortgage as set forth herein.

NOW, THEREFORE, for and in consideration of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Borrower and Lender agree that the Mortgage is amended as follows:

- 1. The principal amount of the Loan has been increased by an additional \$788,704.24, as evidenced by a Loan Modification Agreement and Amendment to Loan Documents executed by Borrower and Lender as of the date hereof. All references in the Mortgage to the sum of "EIGHT MILLION FIVE HUNDRED THOUSAND AND NO/100 DOLLARS (\$8,500,000.00)" (however written) are hereby deleted and the amount of "NINE MILLION TWO HUNDRED EIGHTY-EIGHT THOUSAND SEVEN HUNDRED FOUR AND 24/100 DOLLARS (\$9,288,704.24)" is inserted in lieu thereof.
- 2. All references in the Mortgage to the "Note" shall mean the Promissory Note dated November 30, 2006 in the principal amount of \$8,500,000, as increased to \$9,288,704.24



pursuant to the Loan Modification Agreement and Amendment to Loan Documents dated contemporaneously herewith.

- 3. Exhibit A to the Mortgage shall be amended to add and exclude the property provided on Exhibit A-1 hereto. The property which is excluded shall no longer be subject to the Mortgage.
- 4. The Mortgage shall continue to secure the Loan, as amended hereby and by the Loan Modification Agreement and Amendment to Loan Documents.
- 5. Except as modified herein, all other terms and conditions of the Mortgage shall remain in full force and effect.
- 6. This document may be executed in a number of identical counterparts, each of which for all purposes is deemed an original, and all of which constitute collectively one (1) document and agreement, but in making proof of this document, it shall not be necessary to produce or account for more than one such counterpart, and counterpart pages may be combined into one single document.






