KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 14th day of May, 2008, Jermaine Snow, a single man, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as nominee for Capstone Mortgage Inc. d/b/a Baker Group, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20080519000201610, said mortgage having subsequently been transferred and assigned to Franklin American Mortgage Company, by instrument recorded in Instrument No: 200505000165720, in the aforesaid Probate Office ("Transferee"); and

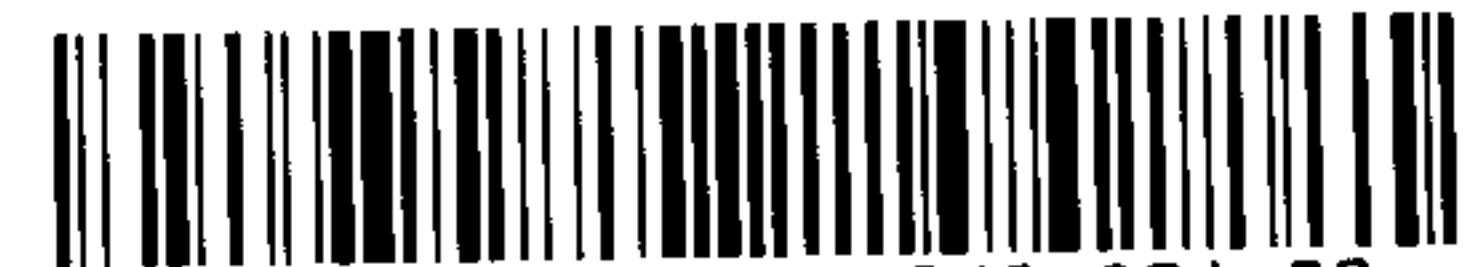
