THIS AGREEMENT is made and entered into on this 19 day of June, 2009, by Regions Bank (Hereinafter referred to as "Regions") in favor of **MORTGAGE ELECTRONIC REGISTRATION SYSTEMS, INC., AS NOMINEE FOR QUICKEN LOANS INC.**, its successors and assigns (hereinafter referred to as "Lender").

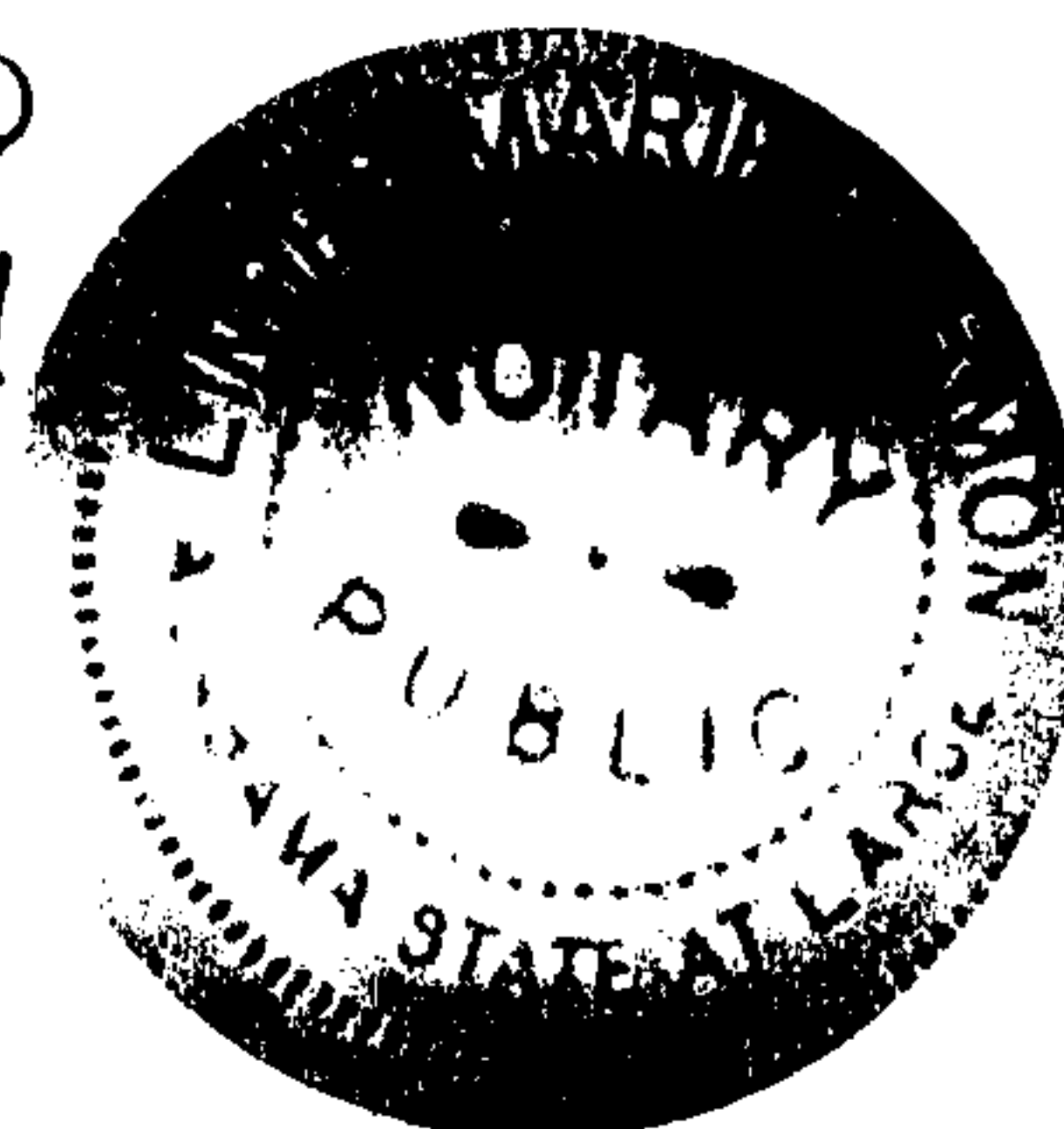
