FIRST: The name of the Limited Liability Company (the "Company") is New Life Homes, L.L.C.

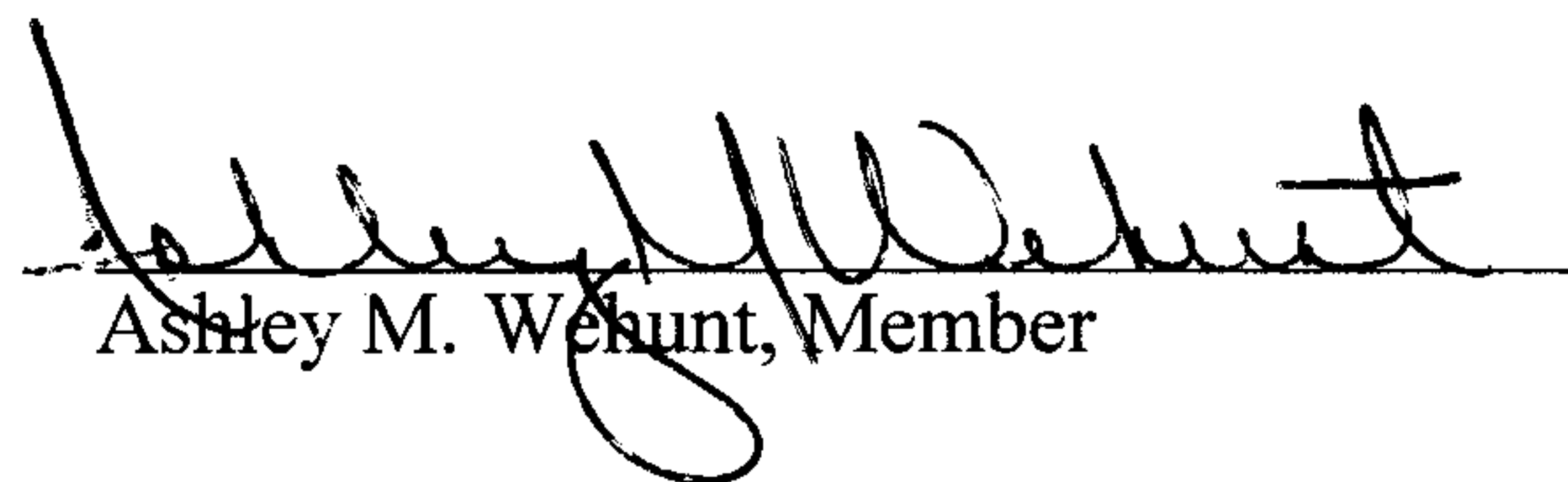
SECOND: The Articles of Organization of the Company were filed on April 26, 2007, in the Shelby County Office of the Judge of Probate.

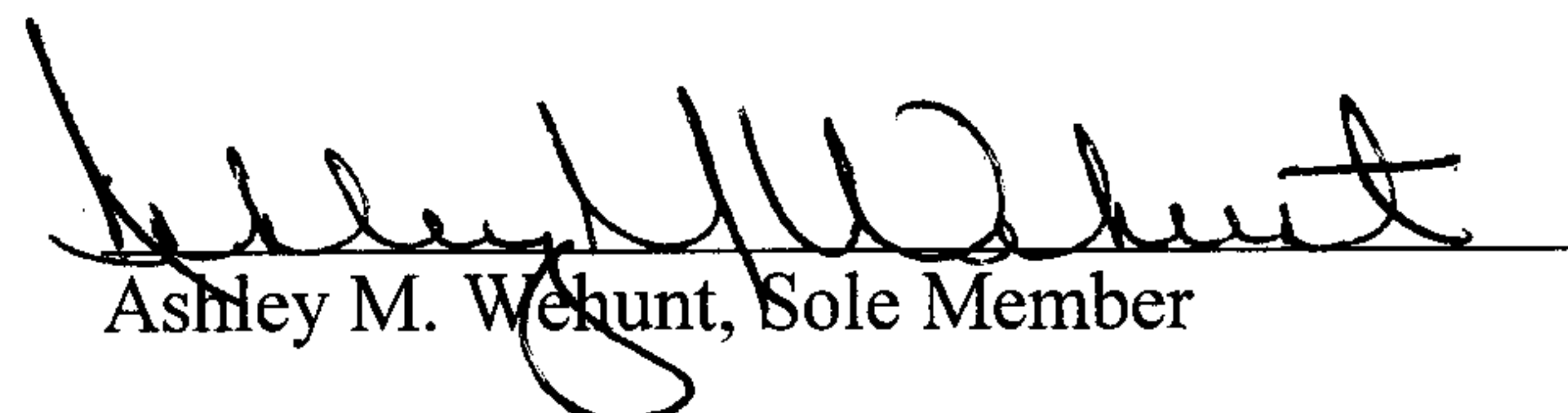
EXHIBIT "A"

MEMBERS' WRITTEN CONSENT TO
DISSOLUTION OF

5. The Members further agree that, on completion of all liquidation procedures, the Members of the Limited Liability Company are authorized and directed to file all documents required by law to complete the winding up of the affairs and the dissolution of the Limited Liability Company.
