

ARTICLES OF INCORPORATION

OF

FRIENDS OF PI KAPPA PHI, ALPHA ETA, INC.

Pursuant to the provisions of the Alabama Non-Profit Corporation Act, the undersigned hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the nonprofit corporation shall be Friends of Pi Kappa Phi, Alpha Eta, Inc. (hereinafter the Corporation).

ARTICLE II - DURATION

The duration of the Corporation shall be perpetual.

ARTICLE III - PURPOSE AND POWERS


The Corporation has been organized for the purpose of the provision of scholarships and charitable endeavors for the organization and for any other lawful purpose. The Corporation shall have all powers now conferred, or which may be conferred upon a non-profit corporation, under the laws of the State of Alabama which are not in conflict with the terms of these Articles.

ARTICLE IV - MEMBERSHIP

The Corporation shall have a Managing Director and a Secretary/Treasurer, and any other class of members as shall be set forth in the Corporation's Bylaws, which shall include the manner of election or appointment and the qualifications and rights of each class. No Director shall have any right, title or interest in or to any property of the Corporation.



ARTICLE VIII - BYLAWS

The Corporation as hereinabove provided shall have the power to adopt Bylaws for the regulation of its internal affairs and for all other purposes not inconsistent with the constitution and laws of the State of Alabama, and with these Articles of Incorporation.

ARTICLE IX - DEBTS AND PERSONAL LIABILITY

No member, officer or Director of the Corporation shall be personally liable for the debts,



obligations or liabilities, or costs and expenses of the Corporation of any nature whatsoever, nor shall any of the property of the members, officers or Directors be subject to payment of the debts, obligations or liabilities, or costs and expenses of the Corporation. The foregoing shall be in addition to and not exclusive of all rights to which such member, officer or Director may be entitled.

ARTICLE X- AMENDMENT

Amendments to the Articles of Incorporation shall be made in the following manner: The Board of Directors may adopt amendments to the Articles of Incorporation by majority vote.

ARTICLE XI - DISSOLUTION

Upon the dissolution of the Corporation, assets shall be distributed by the Board of Directors for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations as said Court determines are organized and operated exclusively for such public purpose.

ARTICLE XII - OTHER PROVISIONS

No part of the net earnings of this Corporation shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes of the Corporation as set forth above. Notwithstanding any other provision of these Articles, this Corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or a corresponding section of any future federal tax code.




