KNOW ALL MEN BY THESE PRESENTS: That Nibesh Shome and Marilyn Gilmore, Husband and Wife as Joint Tenants did, on to-wit, the May 26, 2006, execute a mortgage to Long Beach Mortgage Company, which mortgage is recorded in Instrument# 20060609000275090; said mortgage was transferred and assigned to Deutsche Bank National Trust Company, as Trustee for Long Beach Mortgage Loan Trust 2006-6 as recorded in Instrument# 20081212000464240 et seq., in the Office of the Judge of Probate of Shelby County, Alabama; and




