## **Subordination Agreement**

THIS AGREEMENT is made and entered into on this 5 day of June, 2009, by Regions Bank (Hereinafter referred to as "Regions") in favor of MORTGAGE AMERICA INC., its successors and assigns (hereinafter referred to as "Lender").

## RECITALS

Regions loaned to Reginald G Hurst and Stephanie R Hurst (the "Borrower", whether one or more) the sum of \$ \$26,000.00. Such loan is evidenced by a note dated 9/28/2005, executed by Borrower in favor of Regions Bank, which note is secured by a mortgage, deed of trust, security deed, to secure debt, or other security agreement recorded 10/19/2005, in Record Book I#20051019000543090 at Page N/A, amended in Record Book I#20061207000595080 AND I#20080501000178640 at Page N/A in the public records of SHELBY COUNTY, ALABAMA (the "Regions Mortgage"). Borrower has requested that lender lend to it the sum of \$155,677.00 which loan will be evidenced by a promissory note, and executed by Borrower in favor of Lender (the "Note"). The Note will be secured by a mortgage of the same date as the Note (the "Mortgage"). Lender and Borrower have requested that Regions execute this instrument.

## **AGREEMENT**

In consideration of the premises and for other good and valuable consideration, the receipt and sufficiency of all of which is hereby acknowledged, Regions agrees that the Mortgage shall be and remain at all times a lien or charge on the property covered by the Mortgage prior and superior to the lien or charge of Regions Bank to the extent the Mortgage secures the debt evidenced by the Note and any and all renewals and extensions thereof, or of any part thereof, and all interest payable on all of said debt and on any and all such renewals and extensions, and to the extent of advances made under the Note of the Mortgage necessary to preserve the rights or interest of Lender thereunder, but not to the extent of any other future advances.

By its acceptance of this agreement, the borrower agrees to pay the subordination Fee set out in the Regions Subordination Request Form.
