## ORDER FOR POSSESSION AND QUIET TITLE AGAINST HUGH TODD SCOTT AND ARTHUR C. SCOTT

This matter came before the Court upon the Application, Affidavit, and Entry of Default filed by Crusader Servicing Corporation as Custodian for Strategic Municipal Investments, LLC ("Crusader"). Crusader requests this Court to quiet title in its favor against Hugh Todd Scott ("H. Scott") and Arthur C. Scott ("A. Scott") with respect to the property described as follows:
