**ARTICLES OF ORGANIZATION  
OF  
THE CHUNKY MONKEY, L.L.C.**

Pursuant to the Provisions of Act No. 93-724 of the 1993 Alabama legislature of the Alabama Limited Liability Company Act ("Act"), the undersigned hereby adopts the following Limited Liability Company Articles of Organization:

**ARTICLE I  
Name**

The name of the limited liability company ("Company") is The Chunky Monkey, LLC.

**ARTICLE II  
Duration**

The Company shall be dissolved, and its affairs wound up, upon the occurrence of the first of the following events:


- (i) the unanimous written consent of the Members to dissolve the Company;
- (ii) an event of dissociation of a member pursuant to Section 10-12-36 of the Act, unless there are at least two Remaining Members (or at least one Remaining Member and a new Member is admitted) and the legal existence and business of the Company is continued by unanimous consent of the Remaining Members within ninety (90) days thereafter;
- (iii) when the Company is not the successor in a merger or a consolidation of the Company with one or more entities; or
- (iv) upon the entry of a decree of judicial dissolution pursuant to Section 10-12-38 of the Act.

**ARTICLE III**

The purposes for which the Company is formed are as follows:

- (a) To engage in a retail business to sell merchandise such as Baby and Children's clothing, gifts, etc.
- (b) To provide the service of embroidery/monogram.
- (c) To engage in any other lawful act or activity for which limited liability companies may

be organized pursuant to the Act.

##### **Registered Agents and Office**

#### **ARTICLE V**

##### **Initial Members**

#### **ARTICLE VII**

##### **Admission of New Members**

Members of the Company have the right to admit new members on the unanimous written consent of the existing members. The existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted.

#### **ARTICLE VIII**

The remaining members of the Company shall have the right to continue the business after an event or dissociation terminates the continued membership of a member in the Company on the unanimous written consent of the remaining members.
