## AMENDMENT TO THE ARTICLES OF ORGANIZATION FOR ALABAMA SNOW, LLC,

Pursuant to Section 10-22-11 of the 1975 Code of Alabama, the Limited Liability Company hereby Amends the Articles of Organization because the members desire to make a change in one or more statements in the Articles of Organization to accurately represent the agreement between them.

- 1) The limited liability company's present name is Alabama Snow, LLC.


