FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on to-wit: the 5th day of May, 2006, Dwelling Places, Inc., an Alabama corporation, did execute a certain mortgage on property herein described to Superior Bank, which said mortgage is recorded as Document Number 20060522000242020 in the Office of the Judge of Probate of Shelby County, Alabama.

WHEREAS, on the 18th day of August, 2009, the day on which the foreclosure sale was to be held under the terms of said notice between the legal hours of sale, said foreclosure was duly and properly conducted and Superior Bank did offer for sale and sell at public outcry in front of the Courthouse door in Shelby County, Alabama, the property hereinafter described:

WHEREAS, Robert W. Wolfe was the Auctioneer who conducted the said foreclosure sale and was the person conducting the sale for Superior Bank, and Superior Bank, was the best and highest bidder in the amount of Six Hundred Fifty-Eight Thousand, Seven Hundred Eighty-Six and 70/100 Dollars (\$658,786.70) which sum of money is offered as credit on the indebtedness secured by said mortgage; and said property was thereunto sold to Superior Bank
