Timothy L. Hunter and his wife Laura R. Hunter (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto

Jeremy D. Taylor and Kimberly A. Taylor

(herein referred to as grantees) as joint tenants with right of survivorship, , the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 22, Block 2, according to the First Addition to Selkirk, a subdivision of Inverness, Phase IV, as recorded in Map Book 7, page 149 in the Probate Office of Shelby County, Alabama.

.Subject to: All easements, restrictions and rights of way of record.

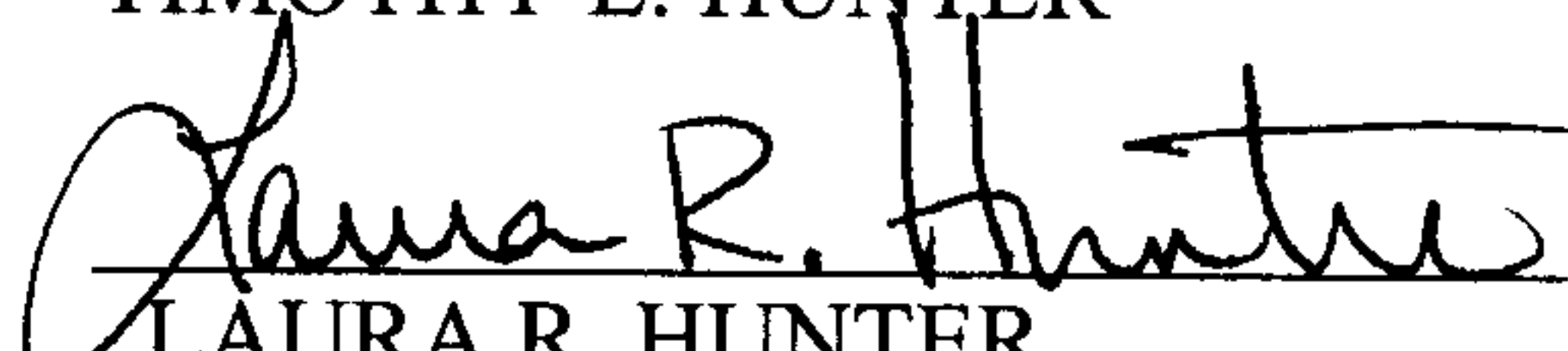
\$268,721.00 of the above mentioned purchase price was paid for from a mortgage loan which was closed simultaneously herewith.

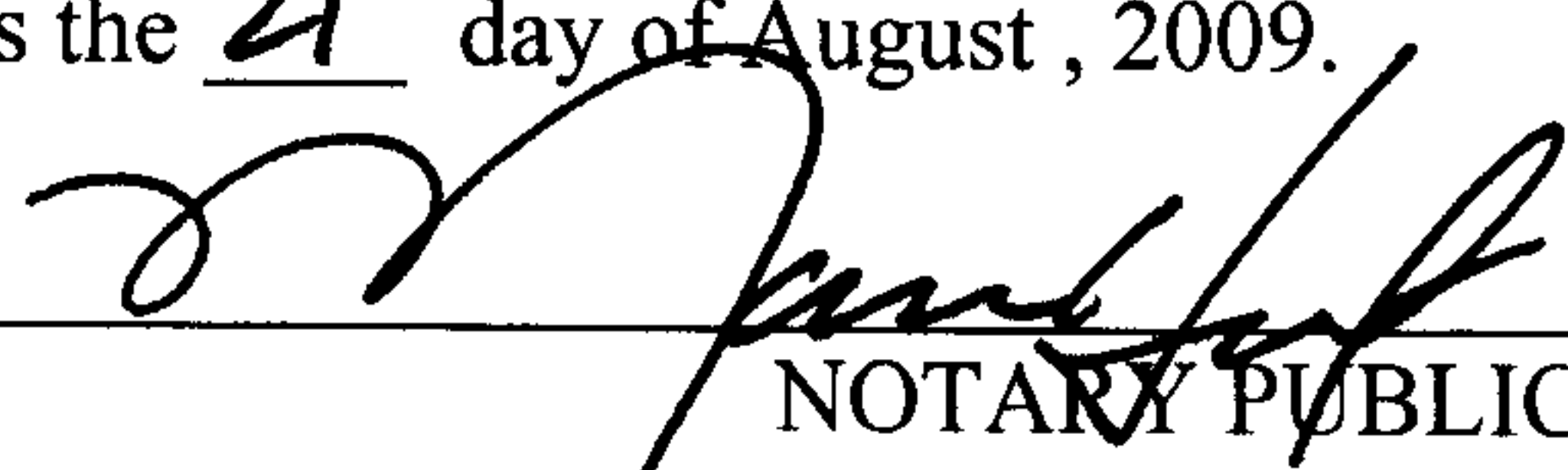
