THIS TERMINATION OF TEMPORARY ACCESS EASEMENT AGREEMENT is made this 26th day of August, 2009, by and between **RIME HOLDINGS, LLC**, an Alabama limited liability company, successor in title to SEIL, CO., LLC, an Alabama limited liability company ("RIME") and **D.R. HORTON, INC. – BIRMINGHAM**, an Alabama corporation ("DRH").

WITNESSETH:
