COMES NOW, The Ladies Auxiliary of Hannah Home Shelby County, Inc., by and through the undersigned President and Secretary, and according to the Alabama Non-Profit Corporation Act, does hereby adopt and amend its Restated Articles of Incorporation. These Amended Articles of Incorporation are intended to affect the following two Articles only and in no way is intended to supercede any other provision of its Restated Articles of Incorporation. The following two amendments were duly adopted as required by law and are as follows:

### ARTICLE I

The name of the corporation shall be changed from The Ladies Auxiliary of Hannah Home Shelby County, Inc. to Hannah Home Shelby Auxiliary, Inc.

#### ARTICLE V

(a) Sentence Two of Article V shall be deleted and the following shall be inserted, "The Directors shall be elected and/or appointed as set forth in the By-laws". The remainder of Article V is unchanged.

These two amendments were adopted by The Board of Directors on or about April 7, 2008 in accordance with Alabama law.

This Amended Articles of Incorporation is intended to amend the foregoing two articles only and in no way is intended to change, alter or amend its charitable purpose, internal revenue exemption, or any other article or matter whatsoever.


