WITNESS THIS AGREEMENT entered into this 3/ day of March, 2008, by and between the City of Pelham, Alabama, an Alabama municipal corporation (hereinafter "City"), and Susan Schein Chrysler, Dodge, Inc., a corporation (hereinafter "Susan Schein"):

WHEREAS, Susan Schein has requested that City, at City's cost, extend the hereinafter described City sewer line located within the U. S. Highway 31 right-of-way from its current terminus to a point within said right-of-way adjacent to the Susan Schein Chrysler, Dodge dealership, and

WHEREAS, as an inducement to City to extend said sewer line, Susan Schein has agreed that in the event the current ownership of Susan Schein Chrysler, Dodge changes or in the event the current operation at said site is moved or substantially decreased in size, the said Susan Schein will reimburse City for the cost of construction of said sewer line, if such occurs prior to the time City fully recovers the cost of construction of said line through sales tax revenues generated on-site by Susan Schein, and

WHEREAS, City, subject to the terms and conditions contained herein, has agreed to extend the aforesaid sewer line:

NOW, THEREFORE, in consideration of the above premises and in consideration of the mutual covenants and agreements contained herein, the parties hereto do hereby agree, covenant, and contract as follows:

twenty-four-inch (24") gravity main located within the right-of-way of U. S. Highway 31 and will extend the aforesaid eight-inch (8") sewer line to a point within said highway right-of-way immediately adjacent to the Susan Schein Chrysler, Dodge dealership at a cost to City of approximately Seventy Thousand Dollars (\$70,000). Susan Schein agrees that should Susan Schein sell or move the existing dealership being operated as Susan Schein Chrysler, Dodge, substantially reduce the size or sales therefrom, or conveys said property upon which the same is situated, or any part of the business located thereon, to any other person, firm, or corporation, prior to the time City fully recovers from sales tax revenues paid to City from said site, the approximate \$70,000 cost of extending said line, then and in that event said Susan Schein will immediately reimburse City for all remaining installation costs minus any sales tax revenue which the specific property now known as Susan Schein Chrysler, Dodge generates from the date of connection to said extended sewer line.


