



**ARTICLES OF ORGANIZATION

An Alabama Limited Liability Company

Pursuant to the provisions of Sections 10-12-1, *et seq.* of the Code of Alabama (1975), the undersigned hereby adopts the following Limited Liability Company Articles of Organization.

ARTICLE I
Name

The name of the limited liability company is ORTHOPEDIC RECONSTRUCTIVE SERVICES, LLC, an Alabama Limited Liability Company (the "Company").

ARTICLE II
Duration

The term of the Company shall commence on the date of the filing of these Articles of Organization in the Office of the Judge of Probate for Shelby County, Alabama, and shall continue in perpetuity, provided, however, that the Company shall terminate and dissolve prior to such date (a) upon the unanimous written consent of the member(s); (b) as provided in the Operating Agreement; or (c) as may be required by the Alabama Limited Liability Act.
