

**ARTICLES OF ORGANIZATION OF
Burton Advertising, LLC**

Pursuant to the Alabama Limited Liability Company Act, the undersigned hereby adopts the following Articles of Organization.

ARTICLE I **NAME.** The name of said limited liability company shall be Burton Advertising, LLC ("Company"), and all business of the Company shall be conducted in such name. The Company shall hold all of its property in the name of the Company and not in the name of any Member.

ARTICLE II **DURATION.** The period of duration of the Company shall be perpetual unless dissolved in accordance with the provisions of the Operating Agreement executed by the Members or the Alabama Limited Liability Company Act.

ARTICLE III **PURPOSE.** The purposes for which the Company is formed are:

(A) Advertising and Marketing

(B) to exercise any and all powers as a natural person, to do all things necessary and convenient to carry out its business and affairs as set forth in Section 10-12-4, Code of Alabama, 1975, as amended from time to time, and to do all things reasonably connected with the Company's business; to accomplish any lawful business whatsoever which shall at any time appear conducive to or expedient for the protection or benefit of the Company and its assets, to engage in all activities necessary, customary, convenient, or incident to any of the foregoing; and

(C) to engage in such other lawful acts or activities for which limited liability companies may be formed under the Code of Alabama.

ARTICLE IV **OFFICE AND AGENT.** The registered agent for Company is Johnathon Mack Burton, whose address is 212 Oaklyn Hills Drive, Chelsea, AL 35043. The address of the principal office of Company is 212 Oaklyn Hills Drive, Chelsea, AL 35043

ARTICLE V **MEMBERS.** The name and address of the initial Member is as follows:

ARTICLE VI **ADDITION OF MEMBERS.** The Operating Agreement shall define when, if and how additional member can be admitted.

ARTICLE VII **DISSOLUTION.** The Operating Agreement shall address the circumstances, if any, under which cessation of membership of one or more members will result in dissolution.

ARTICLE VIII **MANAGER.** The Limited Liability Company is to be Managed by a primary Manager who shall serve until a successor is elected and qualifies. The initial primary Manager shall be Johnathon Mack Burton.

ARTICLE IX **OWNERSHIP UNITS.** The maximum number of ownership units which Burton Advertising, LLC, is authorized to have is one thousand (1000). Units shall be issued as follows:
