\$ 138,500.00 of the above consideration was paid from the proceeds of a mortgage loan closed simultaneously herewith.

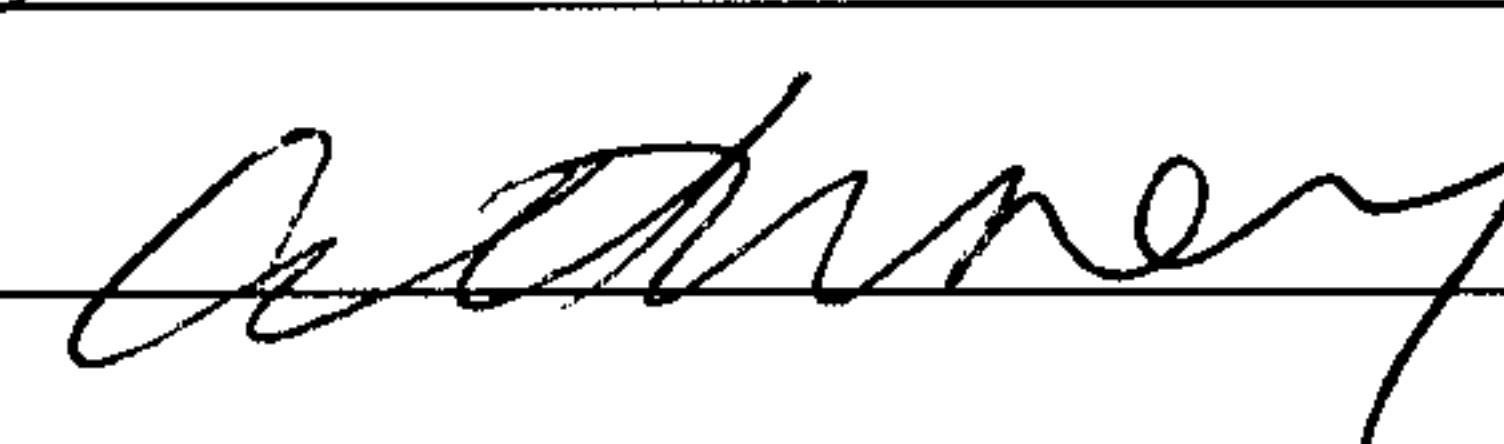
