

ARTICLES OF ORGANIZATION OF

S & H INVESTMENTS, LLC

Pursuant to the Alabama Limited Liability Company Act, as amended, the undersigned hereby adopts the following Articles of Organization.

ARTICLE I

NAME

The name of the Limited Liability Company is S & H Investments, LLC.

ARTICLE II

PERIOD OF DURATION

The period of duration of the Limited Liability Company shall be perpetual and indefinite in nature until further action to the contrary is taken, if any, according to the Articles of Organization or Operating Agreement.

ARTICLE III

PURPOSE

The purpose for which the Limited Liability Company is organized is to engage in any lawful business and as authorized by § 10-12-3, *Code of Alabama* (1975), as amended, and the laws of the State of Alabama. The Limited Liability Company shall have and without limitation those powers as set out in § 10-12-4, *Code of Alabama* (1975), as amended.

The Limited Liability Company may conduct business and otherwise carry out its purposes and exercise its powers in any state, territory, district, or possession of the United States, or in any foreign country, to the full extent permitted by the laws of the state, territory, district, or possession of the United States, or by the foreign country, and it may limit its purpose or purposes in any state, territory, district or possession of the United States, or foreign country.

ARTICLE IV

REGISTERED AGENT AND OFFICE

The initial registered agent of the Limited Liability Company shall be Harry A. Drasutis, and the initial registered office of the Limited Liability Company in the State of Alabama shall be located at 223 Highland Park Drive, Birmingham, Alabama 35242.
