ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION GUIDELINES

INSTRUCTIONS (PLEASE TYPE)

FILE THE ORIGINAL AND TWO COPIES IN THE COUNTY WHERE THE ORIGINAL ARTICLES OF INCORPORATION ARE FILED. IF THE AMENDMENT CHANGES THE NAME, THE SECRETARY OF STATE'S FEE IS \$10. OTHERWISE, THERE IS NO FEE FOR FILING A NON-PROFIT AMENDMENT. THE PROBATE JUDGE'S MINIMUM FEE FOR FILING AN AMENDMENT IS \$10.

PURSUANT TO THE PROVISIONS OF THE ALABAMA NONPROFIT CORPORATION ACT, THE UNDERSIGNED HEREBY ADOPTS THE FOLLOWING ARTICLES OF AMENDMENT.

Article I The name of the corporation:
Christ Pentecostal Church at Oak Mountain, Inc.


Article II The following amendment was adopted:
The new name shall be Oak Mountain Community Church, A Pentecostal
Holiness Church, Inc.

Article III The date of the meeting of the members where the amendment was adopted, a quorum was present, and the amendment received at least two-thirds of the votes entitled to be cast:

Article IV If there was no meeting, attach a statement that such amendment was adopted by written consent and signed by all members entitled to vote.

Article V If there are no members or no members are entitled to vote, attach a statement indicating this fact, the date of the Board of Directors meeting at which the amendment was adopted, and that the amendment was adopted by the vote of a majority of the directors in office.

On Sunday, August 2, 2009, the congregation was presented with a ballot containing a list of new names for the church to be voted on. Each congregation member was given the opportunity to vote on the name he/she wanted. The ballots were counted by Lead Pastor, Gene Brown, and the name that was chosen by majority vote of the congregation was deemed the new name. By majority of the votes the congregation chose Oak Mountain Community Church, A Pentecostal Holiness Church, Inc. to be the new name of the church.

Once the congregation chose the new name, a meeting was held on August 19, 2009 by Lead Pastor, Gene Brown; Alpha Conference Superintendent, Bishop David Stephens; and Board Members, Jeff Powell, Jeff Elkins and Tom Johnson wherein they ratified and accepted the new name chosen by the congregation.

The new name, Oak Mountain Community Church, A Pentecostal Holiness Church, Inc., was officially announced to the church on August 30, 2009.

The name change was effective August 30, 2009.
