


ARTICLES OF ORGANIZATION OF SWEET PEA DESIGNS, LLC

- 1. The name of the limited liability company is Sweet Pea Designs, LLC, hereinafter referred to in these Articles of Organization as the "Company."
- 2. An Alabama general partnership is hereby being converted to a limited liability company from a partnership pursuant to Section 10-8A-901, et seq., of the Alabama Uniform Partnership Act (1996) (the "Partnership Act"), with the effect set forth in Section 10-8A-904 of the Partnership Act. The former name of the partnership from which the Company is being converted is Sweet Pea Designs, an Alabama general partnership of which Anne M. Johnson and Kim S. Kreis were the only partners. The conversion was approved by all of the partners of the converted partnership in accordance with Section 10-8A-902 of the Partnership Act.
 - 3. The period of the Company's duration is perpetual.
- 4. The purpose for which the Company is organized is the transaction of any and all lawful business for which a limited liability company may be organized under the Alabama Limited Liability Company Act, including, without limitation, the business of designing and selling stationary.
- 5. The location and mailing address of the initial registered office of the Company is 5521 Lakes Edge Drive, Birmingham, Alabama 35242. The name of its initial registered agent at that address is Anne M. Johnson.
 - 6. The names and mailing addresses of the initial members of the Company are:

- 7. Prior to the adoption of an Operating Agreement, the members shall have the right to admit additional members to the Company upon the affirmative vote of members holding at least a majority of the membership interest in the Company. Thereafter, the members shall have the right to admit additional members to the Company in accordance with the terms and conditions of the applicable provisions of the Operating Agreement of the Company.
- 8. Except as specifically required by any non-waivable provisions of the Alabama Limited Liability Company Act or any provisions of the Operating Agreement of the Company, the cessation of membership in the limited liability company by any member shall not result in the dissolution of the limited liability company.



9. Management of the Company shall be vested in managers. There shall be two (2) initial managers of the Company, and the names and addresses of the persons who are to serve as such initial managers until their successors are elected and begin serving are as follows:


