KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 7th day of May, 2004, Toni M. Carter-Hairston and Kenton Hairston, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. solely as nominee for 1st Mariner Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 20040514000257670, said mortgage having subsequently been transferred and assigned to CitiMortgage, Inc., by instrument recorded in the aforesaid Probate Office ("Transferee"); and


